Sue stated that, for as many years as she can remember, we have always been lenient and placed assessments on the roll regardless of whether paperwork was complete. She wanted the Board to be aware that she planned to send letters to these districts informing them that this will be the last year we will place their assessments on the roll without the proper documents. No action was taken by the Board.

SARAH HANSON – DAS IGA FOR TAX STATEMENT SERVICES

Approval of this IGA was removed from the consent agenda earlier to give the Commissioners a chance to review it. They have now reviewed the IGA for printing services and discussed it with Sarah and are okay to move forward with approval. With that, *Commissioner Heimuller moved and Commissioner Hyde seconded to approve the Intergovernmental Agreement with the*

Oregon Department of Administrative Services for Document Publishing, Processing and Delivery and authorize the Chair to sign. The motion carried unanimously.
