WORK SESSION MINUTES January 16, 2019

The Columbia County Board of Commissioners me in scheduled session with Commissioner Henry Heimuller, Commissioner Margaret Magruder and Commissioner Alex Tardif.

BOARD DISCUSSION ITEMS:

REVENUE ADVISORY COMMITTEE:

Sarah talked about the resolution creating the committee and answered Board questions about the timing of the committee's expected recommendations. Commissioners Magruder and Heimuller gave their feedback to Commissioner Tardif, who will lead the committee, and Karen Kane about the sectors represented on the committee as well as possible individuals to appoint. To date, Commissioner Tardif has received positive feedback from seven people throughout the county. He will continue to work to fill appropriate spots on this limited-duration committee.

FINALIZED RUN CUTS AND STIF DISCRETIONARY FUNDS:

Todd Wood, Transit Director, presented the Board with an update on the run cuts with added changes that included requests from the public. Todd discussed upcoming discretionary funding opportunities and let the Board know that he would be bringing

drafts to the next work session. Lastly, Todd briefly addressed the continued budget issues at the Transit Center.

While present, Todd introduced Jennifer Moen who is interested in serving on the Transit Advisory Committee. Jennifer explained why she is interested in serving and what she believes she can bring to the committee.
