COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

March 24, 2004

The Columbia County Board of Commissioners met in scheduled session with Commissioner Rita Bernhard, Commissioner Anthony Hyde, and Commissioner Joe Corsiglia, together with Sarah Tyson, Assistant County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Bernhard called the meeting to order and led the flag salute.

MINUTES:

Commissioner Hyde moved and Commissioner Corsiglia seconded to approve the minutes of the March 17, 2004 Board Meeting; March 17, 2004 Staff Meeting; and March 17, 2004 Board/Planning Commission meeting. The motion carried unanimously.

VISITOR COMMENTS:

Peggy Crisp, 34571 Millard Road, Warren, updated the Board on Asburry Park. She presented a map that they will be submitting to DSL. DSL said the more letters of support they receive, the more lenient they will be. She asked for a letter of support from the Board. Hopefully they will be ready by next week to send everything in. Commissioner Hyde suggested that Peggy also ask RC&D and the CSWCD for a letter of support.
