#### **MINUTES**

# January 27, 2010

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde, Commissioner Earl Fisher and Commissioner Rita Bernhard, together with Sarah Hanson, County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Hyde called the meeting to order and led the flag salute.

## **MINUTES:**

Commissioner Bernhard moved and Commissioner Fisher seconded to approve the minutes of the January 20, 2010 Board meeting and January 20, 2010 Staff meeting. The motion carried unanimously.

Commissioner Hyde reported on the very productive retreat the Board held last Friday. Along with the Finance Director, they went through the entire budget in detail.

He was very happy with election results last night. Both Measures 66 & 67 passed.

Yesterday, he attended what he felt was the most productive meeting yet in Vernonia on the school project.

On Monday, he flew to Corvallis to speak about the Vernonia project. With the economic turnaround, the Ford Foundation is back in business and they may be a big donor to this project.

## **COMMISSIONER FISHER COMMENTS:**

Commissioner Fisher has been working on tasks he was assigned during the recent Board retreat.

He had discussions with Clatsop County on the LNG project and how that may impact Columbia County.

He attended an ESD meeting in Hillsboro and a lot of discussion was held on Ballot Measures 66 & 67 and how that vote will effect school funding.

Public Health spoke at the Clatskanie Kiwanis meeting last night.

The Board will be conducting their annual inspection of the Jail facility today at noon.

## **COMMISSIONER BERNHARD COMMENTS:**

Commissioner Bernhard was very excited to see that BM 66 & 67 passed last night. Hopefully this will help our situation in Columbia County.

She attended an Economic Opportunity meeting in Scappoose last night. The City of Scappoose is looking at expanding their UGB. They have hired a consultant to prepare the study. They are also looking at establishing an Enterprise Zone. Scappoose is growing rapidly and they are trying to prepare for that.

She was at a CAT meeting last Monday. A lot of discussion was held on the foreclosure problems in this county. CAT is working with local citizens in our community who are faacing this problem and it seems to be helping. CAT is a tremendous resource for a lot of different situations.

She commented on the Board retreat held recently and felt it was a very productive meeting.

Thursday, the Board met with representatives from ODOT on a variety of projects in Columbia County. It's very helpful to have this open line of communication with ODOT.

The Board recessed the meeting at 10:25 am and will reconvene at 12:00 noon at the Columbia County Corrections Facility for their annual inspection of the Jail.

There was no Executive Session held.

With nothing further coming before the Board, the meeting was adjourned.
