# COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

#### **MINUTES**

# February 3, 2010

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde and Commissioner Rita Bernhard, together with Sarah Hanson, County Counsel and Jan Greenhalgh, Board Secretary. Commissioner Fisher was not present.

Commissioner Hyde called the meeting to order and led the flag salute.

## **MINUTES:**

Commissioner Bernhard moved and Commissioner Hyde seconded to approve the minutes of the January 26, 2010 Work Session; January 27, 2010 Board meeting and January 27, 2010 Staff meeting. The motion carried unanimously.

#### **VISITOR COMMENTS:**

Richard Melton, Columbia River Hwy, Scappoose: He informed the Board that he has been advised by the ADA out of Washington D.C. to back off from the county. They have submitted paperwork to Department of Justice in D.C. to bring charges against Columbia County for harassment and discrimination against the handicapped. The county has endangered his wife's life. He had to call 911 one night and the police could not find his house because there were no outside lights anymore. When the police asked where his lights were, noting they had been there for over 50 years, he informed them that the County had ordered them down.

- (F) Approve the request by the Sheriff's Office to waive fees for the use of Camp Wilkerson May 21-23, 2010 for Columbia County Search and Rescue Training.
- (G) Order No. 2-2010, "In the Matter of Appointing New Members to the Homeland Security and Emergency Management Commission".
- (H) Federal Fiscal Year 2010 Certifications and Assurances for Federal Transit Administration Assistance Programs and authorize the Chair to sign.

- (I) Incident Management Team Cooperative Assistance Agreement by and between Columbia County and Columbia River Fire and Rescue.
- (J) Hazard Mitigation Grant Program Contract, FEMA DR-1733-OR for the Columbia County Non-Residential Flood Mitigation Project Phase 1 and authorize the Chair to sign.
- (K) Amendment #1 to the Personal Services Contract with Lower Columbia Engineering.

While in Tillamook last Thursday, she also attended the NOHA meeting. The are still working on filling the Director's position to take over in June.

She will be meeting with a new representative from Palomar this afternoon.
