MINUTES

February 10, 2010

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde and Commissioner Rita Bernhard, together with Sarah Hanson, County Counsel and Jan Greenhalgh, Board Secretary. Commissioner Fisher was not present.

Commissioner Hyde called the meeting to order and led the flag salute.

COMMISSIONER HYDE COMMENTS:

Commissioner Hyde attended the kickoff of the new Economic Development Commission last Tuesday. The county and cities will have to show some strong leadership for the first year or so. Some grant funding has been received to get this started.

He has been putting a lot of time into the Vernonia School project. Their budget still \$24 million short so they continue to look for funding resources. He has heard that NW Natural has committed to a large donation to this project.

COMMISSIONER FISHER COMMENTS:

Not present. COMMISSIONER BERNHARD COMMENTS:

Commissioner Bernhard attended the Fair Board meeting this week. There was a lot of discussion on upcoming contracts, agreements, the rodeo courts, race track issues and the upcoming fair. Commissioner Hyde noted that there is a \$30,000 hole in the Fair budget that they also need to deal with.

Commissioner Bernhard talked with a lot of different community groups yesterday about doing the community garden project again this year. The Master Gardeners plan to plant fruit trees this year, although it takes about 3 years until they produce, it will eventually provide another source of food. They also plan to do a large community garden in Vernonia this year because of the need they are seeing in that area.

She attended a GOHBI meeting at the CCMH office. They discussed "wrap-around" services for children that are in the system and in need of all the services provided.

She also attended a NOHA meeting. They continue to struggle with helping the over 2,000 people on the waiting list for housing.

EXECUTIVE SESSION UNDER ORS 192.660(2)(e):

The Board recessed the regular session to go into Executive Session as allowed under ORS 192.660(2)(e). Upon coming out of Executive Session, no action was taken by the Board.

With nothing further coming before the Board, the meeting was adjourned.
