COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

July 28, 2010

The Columbia County Board of Commissioners met in scheduled session with Commissioner Anthony Hyde, Commissioner Earl Fisher and Commissioner Rita Bernhard, together with Robin McIntyre, Assistant County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Hyde called the meeting to order and led the flag salute.

MINUTES:

Commissioner Bernhard moved and Commissioner Fisher seconded to approve the minutes of the July 14, 2010 Board meeting; July 20, 2010 Work Session; July 21, 2010 Board meeting; and July 21, 2010 Staff meeting. The motion carried unanimously.

VISITOR COMMENTS:

Elita Davis, 14040 Hwy 202, Mist, Oregon: She is back again regarding her culvert problem. She has attended a couple of Road Advisory Committee meetings with no resolution. The Board then scheduled time to meet with Ms. Davis during the 8/10/10 work session which will allow them to gather information on this issue.

CONSENT AGENDA:

Commissioner Hyde read the consent agenda in full. Item (I) was pulled for discussion. With no other changes/additions, Commissioner Bernhard moved and Commissioner Fisher seconded to approve the consent agenda as follows:

- (D) Approve out-of-state travel request for Derek White, Emergency Management Director, to attend Washington State Emergency Management Association annual conference in Kennewick, Washington, September 21-23, 2010.

(E) Amendment #26 to the Agreement between Columbia County and Columbia

Community Mental Health, Inc. extending expiration date to September 30, 2010.

- (F) Amendment #1 to the Personal Services Contract with Banner Non-Profits for Court Appointed Special Advocates.
- (G) Personal Services Contract with Community Action Team, Inc. for Healthy Start.
- (H) Amendment #1 to the Personal Services Contract with the Vernonia School District
- (I) Construction Contract with Bergeson Construction for the JJ Collins E. Debris Deflection Boom -2010. (*PULLED FOR DISCUSSION*)
- (J) GIS Data License Agreement with David Evans & Associates, Inc.

The motion carried unanimously.

ITEM (I) - CONTRACT WITH BERGESON FOR JJ COLLINS DEBRIS DEFLECTION:

Robin stated that the contract with Bergeson is ready for approval, however there is one issue concerning the insurance requirements. The Board is aware of the recent increase in the Tort Claim Insurance limits and that is an issue with this contract. Glen Crinklaw stated that the bid met all requirements when it was approved, however, with the increase in insurance taking place in the middle of the process, it no longer meets the insurance requirement which must be in place when the actual contract is approved. Glen stated that this project is ready to move forward and there is only a certain time frame to get this project done. Because this insurance requirement is actually in the transition stage, Glen is asking the Board to approve a waiver of the \$1.5 million insurance requirement and accept the \$1 million coverage already in place. After discussion, Commissioner Fisher moved and Commissioner Bernhard seconded to approved the waiver of the \$1.5 million insurance requirement and accept the \$1 million insurance coverage for this project. The motion carried unanimously.

PAINT CARE CONTRACT:

Robin addressed another contract that is effected by the recent increase in the Tort Claim Insurance requirement. The contract is with Paint Care and they are holding an event this weekend for the collection of old paint. They are aware of the increase in insurance requirements and are working on getting it increased from \$1 million to \$1.5 million so Robin is asking that the Board waive the insurance requirement on this contract for just 4 weeks. That will allow the company to hold their event this weekend and time to obtain the \$1.5 million insurance. After discussion, Commissioner Bernhard moved and Commissioner Fisher seconded to waive the \$1.5 million for Paint Care for 30 days. The motion carried unanimously.
