WHEREAS, on September 30, 1988, the Circuit Court of the State of Oregon for the County of Columbia entered of record the Judgment and Decree in *Columbia County v. Sawyer, et al*, Case No. 88-2106; and

WHEREAS, on October 5, 1990, pursuant to that Judgment and Decree, Columbia County, a political subdivision of the state of Oregon, acquired certain foreclosed real property, including a certain parcel of land situated near the City of Clatskanie which was formerly owned by the Estate of Lizzie Matilda Aho; and

WHEREAS, this property is referred to as Tax Account No. 05-10 8434-010-01801 and is more particularly described as follows:

The Southwest quarter of the Northeast quarter of Section 34, Township 8 North, Range 4 West, Willamette Meridian, Columbia County, Oregon, described as follows:

Beginning at a point in the West side of the said Southwest quarter of the Northeast quarter of Section 34, 400 feet South of the Northwest corner of the Southwest quarter of the Northeast quarter aforesaid; thence East 240 feet; thence South 350 feet; thence West 240 feet; thence North 350 feet to the place of beginning.

WHEREAS, the Board of County Commissioners deemed this property surplus to the County's needs, that the highest and best use would be to an adjoining property owner, and directed that letters be sent to the adjoining property owner(s) advising that the property would be placed for auction; and

WHEREAS, ORS 275.225 permits the County to sell county land by private sale, provided that the property is assessed at less than \$5,000 on the most recent assessment roll prepared for the County, and is unsuited for construction or placement of a dwelling under current zoning ordinances and building codes of the County; and

WHEREAS, the property has been assessed at \$3,000.00, and is unsuited for construction or placement of a dwelling; and

WHEREAS, on December 13, 2002, Bernard P. Reinbold and Mary E. Reinbold submitted a check to Columbia County in the amount of \$545.00, the sum of \$500.00 to purchase this parcel and the sum of \$45.00 to cover recording and handling fees;

WHEREAS, pursuant to ORS 275.225, notice of private sale was published in a newspaper of general circulation on December 18, 2002, and more than 15 days has elapsed since publication of said notice; and

WHEREAS, no further offers have been received by the County pursuant to this notice;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1. Pursuant to ORS 275.225, the Board authorizes the sale of the above-described property to Bernard P. Reinbold and Mary E. Reinbold for \$500.00.
2. The Board of County Commissioners shall execute the Quitclaim Deed for Tax Account No. 05-10 8434-010-01801 to Bernard P. Reinbold and Mary E. Reinbold, a copy of which is attached hereto as Exhibit A and by this reference incorporated herein, for the sum of \$500, receipt of which is hereby acknowledged.

REINBOLD, husband and wife, hereinafter called Grantees, and unto their heirs, successors and assigns, all their right, title and interest in and to the following described parcel of real property situated in the County of Columbia, State of Oregon, described as follows, to wit: Tax Account No. 05-10 8434-010-01801.

The true and actual consideration for this conveyance is \$500.

- 1) This property is conveyed AS-IS without covenants or warranties, subject to any municipal liens, easements and encumbrances of record.
- 2) All rights to any County, public, forest or C.C.C. roads are hereby reserved for the benefit of Columbia County, Oregon.
- 3) All rights to any minerals, mineral rights, ore, metals, metallic clay, oil, gas or hydrocarbon substances in, on or under said property, if any, including underground storage rights, and also including the use of such water from springs, creeks, lakes or wells to be drilled or dug upon the premises as may be necessary or convenient for such exploration or mining operations, as well as the conducting of operations related to underground storage and production of gaseous substances on the property, are specifically excepted, reserved and retained for the benefit of Columbia County, Oregon, together with the right of ingress and egress thereto for the purpose of exercising the rights hereby excepted, reserved and retained.
