WHEREAS, ORS 271.310(1) authorizes Columbia County to sell, exchange, convey or lease their interest in certain real property not needed for public use to any governmental body whenever the public interest may be furthered, the consideration for such transfer being cash or real property, or both; and

WHEREAS, on April 9, 1979, the Circuit Court of the State of Oregon for the County of Columbia entered of record the Judgment and Decree in *Columbia County v. Arola, et al,* Case No. 24964; and

WHEREAS, on April 10, 1980, pursuant to that Judgment and Decree, Columbia County, a political subdivision of the state of Oregon, acquired certain foreclosed real property, including a one-half interest in a parcel of land situated outside the City of Rainier which was formerly owned by The Briarcliff Golf & Country Club, Inc.; and

WHEREAS, the [Rainier] School District # 13 has remained the owner of the remaining one-half interest in and to this same parcel; and

WHEREAS, in an electronic communication dated December 18, 2002, Wayne Kostur, Superintendent for the Rainier School District #13, advised that Rainier School District #13 had accepted the Board of County Commissioners' offer to transfer title of Columbia County's one-half interest in this parcel of County-owned property, generally described as a roadway to property owned by the Rainier School District and located off of the Old Columbia River Highway; and

WHEREAS, a map of the subject property is attached hereto as Exhibit A and by this reference incorporated herein; and

WHEREAS, the County-owned parcel is legally described and given a current assessed value as follows:

Commencing at a point on the North line of the right of way of the Columbia River Highway, 697.79 feet West and 298.81 feet North of the Southeast corner of the Northwest quarter of Northwest quarter of Section 18 in Township 7 North, Range

63°15'18" East 76.77 feet; thence Northerly 84.79 feet along a curve to the right with a radius of 573 feet to a point 537.41 feet West and 394.21 feet North of the said Southeast corner of the Northwest quarter of Northwest quarter; thence North 0°13'55" East 66.72 feet; thence along a curve to the right with a radius of 70 feet through a central angle of 90°27'45" for a distance of 110.52 feet; thence South 89°18'20" East 217.18 feet; thence North 0°41'40" East 30 feet: thence North 89°18'20" West 327.99 feet; thence South 0°13'55" West 264.25 feet; thence North 89°25'55" West 120 feet to the place of beginning.

WHEREAS, Columbia County has determined that the above-described property is not needed for public use and the public interest would be furthered to transfer ownership of this property to the Rainier School District.

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

- 1. Columbia County shall relinquish title to the real property described above to the Rainier School District #13 for the consideration of \$1.00, plus the cost of handling and recording the deed, receipt of which is hereby acknowledged.
- 2. This conveyance shall be by Quitclaim Deed, duly prepared by County Counsel and executed by the Board of Commissioners, a copy of which is attached hereto as Exhibit B and by this reference incorporated herein.


