ORDER NO. 46 - 2003

WHEREAS, on December 29, 1994, the Board of County Commissioners adopted Order No. 338-94 which, among other things, authorized the Mist-Birkenfeld Rural Fire Protection District (RFPD) to apply for reimbursement for a portion of their operational costs due to the impaction on the District by natural gas exploration, development, transportation and storage in the Mist gas fields; and

WHEREAS, this reimbursement would be made to the Mist-Birkenfeld Rural Fire Protection District out of the proceeds received pursuant to ORS 275.275(2); and

WHEREAS, on December 11, 2002, the Mist-Birkenfeld RFPD submitted a list of budgeted expenditures for the 2002-2003 fiscal year, along with the corresponding percentage which is a result of impaction, in the amount of \$116,288, certified to be for the costs described above; and

WHEREAS, the Mist-Birkenfeld RFPD received the sum of \$11,279.24 towards said impaction costs in the December 2002 distribution of the proceeds received pursuant to ORS 275.275(2), leaving a balance due to impaction of \$105,008.76; and

WHEREAS, on June 20, 2003, the Mist-Birkenfeld RFPD submitted an amended list of budgeted expenditures for the 2002-2003 fiscal year, along with the corresponding percentage which is a result of impaction representing the balance of \$96,142, certified to be for the remaining costs described above; and

WHEREAS, the Board has reviewed and approved these costs, and the Columbia County Deputy Treasurer has verified said costs; and

WHEREAS, the relevant billings, certification, approval and verification referred to above are attached hereto and incorporated herein by this reference as follows:

Certificate and Cost Bill..... Exhibit A  
Review and Approval ..... Exhibit B  
Verification ..... Exhibit C;

and

WHEREAS, the amount of funds available for reimbursement for impaction at this time is \$6,463.48, and by prior authorization, the Mist-Birkenfeld RFPD is entitled to 66% of those funds; and

WHEREAS, this matter is now before the Board of County Commissioners for approval of reimbursement in the amount of \$4,265.89 which is the allowable amount of reimbursement for the above-mentioned costs approved pursuant to Order No. 338-94 and Order No. 45-2003;

NOW, THEREFORE, IT IS HEREBY ORDERED that the Mist-Birkenfeld RFPD shall be reimbursed in the amount of \$4,265.89 as a portion of their operational costs due to impaction on the district by natural gas exploration, development, transportation and storage in the Mist gas fields, as described in the attached Exhibit A.



The following is a listing of budgeted expenditures for the 2002-2003 fiscal year and the corresponding percentage which is a result of 'IMPACTION':


