WHEREAS, the Letters of Authority previously issued to Kevin Iverson, Fred Oviatt, Jim Davis, Darin Smith, Mark Kuhn and Doug Bradley, who no longer serve as Fair Board members, should be revoked; and

WHEREAS, the Letters of Authority previously issued to David Thompson, Jr., and Donald Courtain, who continue to serve as Fair Board members, should remain in full force and effect; and

WHEREAS, the current Fair Board Administrator, Evelyn Hudson, is set to retire in the near future, and the Letter of Authority previously issued to Ms. Hudson should be revoked upon the effective date of her retirement; and

WHEREAS, the new Fair Board Administrator, Rhonda Courtney, should be granted authority under the Columbia County Enforcement Ordinance effective May 12, 2004, the first date of her actual employment;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1) Rick Fetterly, Paul Connelly and Deloris Bellingham are granted authority and jurisdiction over, and may enforce, those statutes, administrative rules, ordinances, orders and resolutions, and provisions thereof, as referenced below, upon issuance of a Letter of Authority by the Board of County

Commissioners.

- 2) Rhonda Courtney is granted the same authority outlined in Paragraph 1 above upon the first effective date of her employment.
- 3) The Letters of Authority previously issued to David Thompson, Jr., and Donald Courtain, remain in full force and effect.
- 4) The Letters of Authority previously issued to Kevin Iverson, Fred Oviatt, Jim Davis, Darin Smith, Mark Kuhn and Doug Bradley, are hereby revoked.
- 5) The Letter of Authority previously issued to Evelyn Hudson is hereby revoked upon the effective date of her retirement.
