WHEREAS, on June 9, 2004, the Board of County Commissioners adopted Resolution No. 36-2004 approving the formation of a new Columbia Health District; and

WHEREAS, the Board scheduled a final public hearing on the proposed formation of the new district for July 7, 2004, in the Board of County Commissioners' Meeting Room, Room 308 of the Courthouse Annex in St. Helens, Oregon; and

WHEREAS, the Board caused notice of the public hearing to be published by two insertions in a newspaper as provided by ORS 198.730(2) and 198.810(1); and

WHEREAS, the public hearing was held on July 7, 2004, as scheduled, in order to determine if sufficient written requests for an election had been received, and also to consider whether to put the question of formation and a proposal for a permanent rate limit for the new district on the November 2, 2004, general election ballot; and

WHEREAS, no written requests for an election were filed at or before the final hearing as provided by ORS 198.810, however, the Board heard testimony from supporters and opponents to the new District and testimony regarding the need for, and amount of, a permanent rate limit for operating taxes for the new district, and considered the economic feasibility statement and other materials submitted by supporters of the new district;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

- 1. The Board of County Commissioners finds and approves the stated purpose of the new district, i.e., to create a district and funding method to support a new Critical Access Hospital. The Board further finds that a permanent rate limit of \$0.38 per \$1000 of assessed value would be needed to fund the new Critical Access Hospital.
- 2. The Board of County Commissioners calls for an election to be held on the question of formation of a new Columbia Health District with a permanent rate limit of \$0.38 per \$1000 of assessed value. Said election shall be held on November 2, 2004, the date of the next general election. At such election members of the new district board will be voted for. Candidates to be voted for as members of the first board of the district shall be nominated as provided by ORS Chapter 255 and ORS Chapter 440, the principal Act of the proposed new district. Formation of the new district shall be contingent upon approval by the electors of a measure, also on the November 2, 2004, general election ballot, dissolving the existing Columbia Health District.
- 3. The County elections official shall include with the ballot for the election a map or other

description of the boundaries of the proposed new district using streets and other generally recognized features and a statement of the permanent rate limit proposed for the district.

4. The Board of County Commissioners adopts and approves the Notice of District Measure Election and ballot title which is attached hereto, labeled Exhibit "A", and incorporated herein by this reference.
