In the Matter of Renewing a Franchise for)
Ambulance Services to Clatskanie Rural Fire) Order No. 85-2005
Protection District for Service Area 5 (Clatskanie))

WHEREAS, pursuant to Ordinance No. 90-23 (the "Ordinance"), the Board of County Commissioners adopted Ambulance Service Areas and, pursuant to Section 8 of that Ordinance, the Board mandated that no person may provide ambulance service in Columbia County without being fully franchised in accordance with the applicable provisions; and

WHEREAS, current franchises are due to expire on December 31, 2005; and

WHEREAS, pursuant to Section 9 of the Ordinance, and Order No. 169-5, the Ambulance Service Administrator (the "Administrator") requested franchise renewal applications; and

WHEREAS, also pursuant to Section 9, on October 14, 2005, the Administrator received a renewal application from the Clatskanie Rural Fire Protection District for Area 5 (ASA-5), which is generally the Clatskanie area; and

WHEREAS, pursuant to Section 11 of the Ordinance the Administrator reviewed the renewal application and recommended renewal of the ambulance service franchise for Area 5 to the Clatskanie Rural Fire Protection District; and

WHEREAS, a copy of the Administrator's recommendation is attached hereto as Attachment 1, and is incorporated herein by this reference; and

WHEREAS, pursuant to Section 12 of the Ordinance, the Board of County Commissioners held a public hearing on December 21, 2005, to consider the application;

NOW, THEREFORE, IT IS HEREBY ORDERED that the ambulance service franchise for Service Area 5 is hereby granted to the Clatskanie Rural Fire Protection District for the period beginning January 1, 2006, and ending December 31, 2010.

SUBJECT: ASA Franchise Renewal Recommendations


I have received and reviewed all of the required applications for Ambulance Service Area Franchises from four of the Fire Districts in Columbia County. I also received an application from Metro West Ambulance who serves the Vernonia Fire District by contract.

Each application represents a single Fire Protection District is the sole applicant for each of the Franchise Areas. I have reviewed their applications and found they have provided all the required information. Based on the information provided and their past experience I feel they will provide adequate ambulance service within Columbia County.

I recommend that a franchise to provide ambulance service within each of the Ambulance Service Areas, under the terms, conditions and duties as listed in Columbia County Ambulance Service Ordinance, Number 90-23, be granted to the following applicants beginning January 1, 2006, and ending on December 31, 2010:

Vernonia Rural Fire District/Metro West Ambulance	ASA 7
Mist-Birkenfeld Rural Fire District	ASA 6
Clatskanie Rural Fire District	ASA 5
Columbia River Fire and Rescue District	ASA 3
