WHEREAS, pursuant to ORS 275.200, Columbia County may sell its one-half interest in this parcel at private sale without further notice at such price as the Board of Commissioners deems reasonable, but at a price no less than 15 percent of the minimum bid set under ORS 275.110 for the Sheriff's sale; and

WHEREAS, on March 15, 2005, Columbia County received a written offer to purchase the County's one-half interest in this parcel from Nels and Mona Christensen in the amount of \$110, which exceeds the price requirement of OR\$ 275.200, accompanied by a money order made payable to Columbia County in the amount of \$155 representing the
