NOTICE OF DEPOSIT FORFEITURE

Pursuant to Columbia County Ordinance No. 98-10, as amended, you were required to complete the construction of the permitted access approach in conformance with the Ordinance and as approved by the Public Works Director within 2 years from the date of issuance. Our records indicate that the access approach has not been completed as required. Therefore, the Access Approach Permit Deposit is hereby forfeited.

Pursuant to Ordinance No. 98-10, as amended, the County may, after the expiration of 30 days following the transmittal of a written notice, at your expense, construct or remove the access approach, or reconstruct, repair, or maintain the access approach. Forfeiture of the Permit Deposit does not relieve you of your obligation to complete the Access Approach.

You have the right to appeal the forfeiture. To appeal the forfeiture, you must file a written notice of appeal within 30 days from the date of this Notice. The written appeal must be in the format approved by the Board of County Commissioners. Appeal forms are available at the Columbia County Road Department, 1054 Oregon Street, St. Helens, Oregon 97051 and at the Board of County Commissioners' office, Room 331, Columbia County Courthouse, 230 Strand, St. Helens, Oregon 97051. Forms are also available on the Columbia County website at www.co.columbia.or.us. The written appeal must be received by the Board of County Commissioners within the 30-day period. Upon receipt of a timely written appeal, the Board of County Commissioners will schedule a hearing and you will be notified of the hearing date. At the conclusion of the hearing, the Board of County Commissioners must affirm the forfeiture if you failed to comply with all of the terms of the permit within the specified time period unless you requested an extension of the permit in a timely manner.
