WHEREAS, said refunds were issued and mailed to the addresses indicated on the permits as outlined above; and

WHEREAS, each of the refunds outlined above were returned as undeliverable; and

WHEREAS, account records maintained for access approach deposits indicated that on December 19, 1986, an individual with the last name of "Toman" paid a \$500 deposit for an access approach permit, No. 2327, but no documentation whatsoever can be found related to this permit; and

WHEREAS, County staff have exhausted all reasonable means available in an attempt to locate the above-named applicants without success; and

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1. The deposits listed above are hereby forfeited to the County and the amounts forfeited are to be transferred from the Treasurer's Deposit Account to the County Road Fund.

2. Should these individuals come forward in the future seeking a refund of the access approach permit deposit, the deposit shall be promptly refunded from the County Road Fund.
