### BEFORE THE BOARD OF COUNTY COMMISSIONERS FOR COLUMBIA COUNTY, OREGON

In the Matter of Authorizing Columbia 9-1-1 ) Communications District to Construct a Gate in ) the Right-of-Way of Lookout County Road )

ORDER NO. 62-2006

WHEREAS, pursuant to ORS 368.056, the Board of County Commissioners may authorize the issuance of a permit to a person to allow construction of a gate on a public road under the jurisdiction of the County; and

WHEREAS, in issuing such permit, the Board of County Commissioners may impose any conditions or specifications on the permit it determines to be advisable to preserve the purposes of the public road, and may include a requirement that the person issued the permit shall bear all costs of construction and maintenance of the gate; and

WHEREAS, the Columbia 9-1-1 Communications District ("Columbia 9-1-1") is the owner of critical public safety communications system equipment installed at the Meissner Lookout Radio Site located on property owned by the Oregon Department of Forestry abutting Lookout County Road; and

WHEREAS, Columbia 9-1-1 has requested the authorization to construct a gate in the rightof-way of such Road, a copy of which is attached hereto as Attachment 1, and is incorporated herein by this reference; and

WHEREAS, the other property owners who own property beyond the proposed gate on Lookout County Road have requested increased deterrents to vandals and trespassers to the Meisner Lookout Radio Site and have been notified by Columbia 9-1-1 of the proposed gate construction, and have consented to the gate; and

WHEREAS, the County Road Official has recommended that the County authorize Columbia 9-1-1 to construct and maintain a steel gate at the proposed location provided that the gate is highly visible, provided that there is an advance warning sign and further provided that there is a turnaround in the vicinity; and

WHEREAS, the Columbia County Road Standards prohibits the placement of any structure in the right-of-way of any County road or public road under County jurisdiction without first obtaining a Construction Permit from the Columbia County Road Department;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1. The Columbia 9-1-1 Communications District is authorized to construct and maintain a steel gate at the location shown on the area map which is attached hereto as

Attachment 2, and is incorporated herein by this reference, upon the issuance of a Columbia County Construction Permit by the Columbia County Road Department.

- 2. The above authorization is subject to the following conditions:
  - i. Columbia 9-1-1, its assigns, and successors in interest, shall at all times be solely responsible for the maintenance and repair of such gate. Columbia 9-1-1 shall keep the gate in good repair.
  - ii. The gate shall be constructed of steel with two reflectorized object marker signs (zebra boards) on each side of the gate for visibility purposes.
  - iii. The County Road Department shall install an advance warning sign on Lookout County Road to warn of the presence of the gate, and shall be responsible for the maintenance and replacement of such signage.
  - iv. The County Road Department shall build a turnaround in front of the gate at the location.
  - v. A key to the gate shall be provided to all owners and occupants of property having access onto Lookout County Road beyond the location of the gate, the County Road Department, and to local fire and emergency services operators.
  - vi. Columbia 9-1-1, its assigns or successors in interest, shall remove the gate at its sole expense upon a determination by the Board of County Commissioners that the gate is no longer in the public interest, or immediately upon request of the County Roadmaster if an emergency situation occurs which requires its removal.
  - vii. Columbia 9-1-1, its assigns or successors in interest shall follow all applicable provisions of the Columbia County Road Standards, Ordinance No. 96-6, as may be amended.
  - viii. Columbia 9-1-1, its assigns or successors in interest shall provide insurance in an amount to be determined by the County Roadmaster, and shall indemnify, defend, and hold harmless the County, its Board of Commissioners, the Roadmaster and all other County officers, agents and employees from any claim which might arise on account of the issuance of the Construction Permit, or this Gate Permit. The County Roadmaster shall require a certificate of insurance to be provided.

ix. The Columbia County Roadmaster shall issue a Public Road Construction Permit to Columbia 9-1-1 upon Columbia 9-1-1's compliance to the Roadmaster's satisfaction with all applicable Columbia County Road Standards.

This document is prepared on behalf of the Columbia 9-1-1 Communications District, the users of the site known as Meissner Lookout including the Columbia County Road Department and certain affected property owners on Lookout Road. We are proposing placement of a gate across the county road named Lookout Road, approximately 120 yards east of the intersection of Lookout and Hollywood Roads specifically to reduce the opportunity for unauthorized public access to critical public safety radio site communications equipment and facilities

The Meissner Lookout Radio Site is located at the end of Lookout Road off of Hollywood Road on property owned by the Oregon Department of Forestry (ODF). This radio site has been in existence for many years as a cooperative use site, and has recently been upgraded with newer equipment serving the Columbia County Road Department and the Columbia County Emergency Management Department. Columbia 9-1-1 Communications District recently enhanced its public safety radio system with new equipment at the site to provide for better saturation of radio and data system coverage in the Meissner/Apiary area for the Sheriff and other police responders and for fire emergency medical responders.

The site also houses critical voice communications equipment for the Oregon Department of Forestry, The Rainier School District and ARES/RACES amateur radio group. The State of Oregon may also use this site as they upgrade the radio communication system for the state agencies in our area.

Columbia 9-1-1 Communications District, in collaboration with ODF and the Columbia County Road Department has made significant physical improvements recently to the site. Chain link fencing, gravel pad and driveway and a gate that surrounds the site buildings and towers has been installed. Columbia 9-1-1 is in the process of locating an emergency power generator at the site.

### Page 2 Lookout Road Security Gate Request

The purpose of this request is to add an important security feature that will support the security of a critical radio site and support the peace of mind of neighboring property owners. This site has long been a location of unauthorized late night parties and illegal dumping. Two weeks ago, I picked up enough litter and beer bottles to fill 2 large paper bags. Damage to critical communications links potentially caused by such trespassers is a safety risk that we now have an opportunity to mitigate.


On May 13<sup>th</sup>, 1 met with the property owners in the immediate are of the site. The property owners voice strong support for gating the area to promote security and reduce the presence of people that are not authorized to be at the radio site.

Placing a gate across the entrance road leading to the site would greatly restrict access to the site, yet would not interfere with access by nearby property owners. The gate would be constructed similar to the ones used by timber companies. The recommended manufacturer is based in Vernonia and is the supplier of gate for Longview Fibre timber operations.

On May 23<sup>rd</sup>, Road Department Superintendent Dave Hill and ODF Unit Forester Mike Simek accompanied me to the site and determined the best location for the gate and for a turnaround area. The recommended location is east of the last address on Lookout Road and is a considerable distance from the radio site turnaround.

Approval of the proposal will support the security of this critical radio site and would provide an added benefit to neighboring property owners by reducing the opportunity for unauthorized persons in the area and potentially dangerous use of the site
