**ORDER NO. 91 - 2006**

WHEREAS, since April 3, 1991, the County has been collecting \$500.00 deposits to secure construction of access approaches on County and public roads; and

WHEREAS, for permits issued between April 3, 1991, and November 25, 1998, the applicant was to complete construction within 30 days of issuance, or the applicant would forfeit the deposit; and

WHEREAS, for permits issued after November 25, 1998, the applicant was to complete construction within 2 years of issuance, or the applicant would forfeit the deposit; and

WHEREAS, those permits which have expired are listed on the document attached hereto as Exhibit A, incorporated herein by this reference, and the deposits are subject to forfeiture; and

WHEREAS, notices were mailed to applicants who have not completed construction within the required 30-day or 2-year period on September 29, 2006, as reflected in the attached Exhibit B; and

WHEREAS, pursuant to the notice, each applicant was given the right to appeal the forfeiture within 30 days from the notice; and

WHEREAS, the applicants listed in Exhibit A did not appeal the forfeiture within the time given for appeal.

NOW THEREFORE, IT IS HEREBY ORDERED that the deposits listed in Exhibit A are hereby forfeited to the County and that the funds be transferred from the Treasurer's Deposit Account to the County Road Fund.
