ORDER NO. 14-2007

WHEREAS, the Board of County Commissioners adopted Order No. 15-2006, "In the Matter of Increasing Various Fees for Columbia County Animal Control Services" on February 15, 2006; and

WHEREAS, Order No. 15-2006 amended the fee schedule for dog licenses and kennel licenses and Order No. 1-2007 amended the fee schedule for kennel licenses; and

WHEREAS, the current fee schedule for dog licenses and kennel licenses is Amended Exhibit "B" of Order No. 1-2007; and

WHEREAS, after considering the recommendations of Columbia County Animal Control, the Board has decided to change the due date for dog and kennel licenses and penalty amount for late license applications;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1. Due Date. The due date for dog and kennel licenses shall be March 1 beginning in the year 2007.
2. Penalties. The penalty for not obtaining and/or renewing dog and kennel licenses shall be \$25.00. The enhanced penalty of \$50.00 after March 31 is abolished.
3. Amended Exhibit "B". Re-Amended Exhibit "B", which is attached hereto and incorporated herein by this reference, shall supersede Amended Exhibit "B" of Order No. 1-2007 for dog and kennel licenses issued for the year 2007.

# Columbia County Animal Control

## Dog License Fees

Non-neutered or non-spayed dog .....	\$30.00 per year
Neutered or spayed dog .....	\$12.00 per year
Non-neutered or non-spayed dog owned by senior citizen 65 years of age or older .....	\$15.00 per year
Neutered or spayed dog owned by senior citizen 65 years of age or older (only one senior discount per household) .....	\$5.00 per year

Penalty for failure to purchase annual dog license on time each year:

### Beginning in Year 2007

After March 1:	\$25.00
After citation:	\$75.00

Field License Penalty: Any owner or keeper of an unlicensed dog that would be subject to receiving a citation for failure to obtain a dog license may be issued a field license application, in lieu of citation at the discretion of the animal control officer. A penalty fee will be added to the license fee in the amount of \$10.00 for 2006 and \$25.00 each year after 2006.

Replacement of lost permanent numbered tag .....	\$5.00

## Kennel License Fees

### Beginning in Year 2007

Non-Commercial Kennel license .....	\$150.00
Commercial Kennel license .....	\$200.00
Late Penalty fee after March 1 .....	\$100.00
