Order No. 20-2007

WHEREAS, a majority of the Board of County Commissioners finds that undue harm will result to the following roads, from beginning to end, in the event vehicles in excess of a maximum weight of 10,000 pounds are permitted to travel on the County Roads because of freezing ground (frost heave) and subsequent thawing of the roads:

Smith Road (Columbia City); Robinette Road; Cater Road; Walker Road (St. Helens); Sykes Road; Sierks Road; Pisgah Home Road; Holliday Road; Mt. View Road: Clatskanie Heights Road; Keasey Road; Pebble Creek Road; Alder Grove Road; Shepard Road; and Lindberg Road (Clatskanie); and

WHEREAS, the Roadmaster has presented this Application and Order to restrict the use of said roads in accordance with the requirements of the Columbia County Transportation Ordinance.

NOW, THEREFORE, the Board of Commissioners of Columbia County orders as follows:

- 1. The roads known as Smith Road (Columbia City); Robinette Road; Cater Road; Walker Road (St. Helens); Sykes Road; Sierks Road; Pisgah Home Road; Holliday Road; Mt. View Road; Clatskanie Heights Road; Keasey Road; Pebble Creek Road; Alder Grove Road; and Shepard Road shall be closed to vehicular traffic with a maximum weight in access of 10,000 pounds.
- The Roadmaster shall post the road conspicuously at each end of the section affected by this 2. Order, and shall endorse this Order accordingly.

This Order shall be effective upon recording in the Commissioners' Journal, after the fact of posting has been properly endorsed, and shall remain in effect until June 1, 2007, or sooner if, in the Roadmaster's discretion, the weight limits are no longer needed, and the Roadmaster causes the posting to be removed from one or more of the affected roads.
