WHEREAS, on October 27, 2007, pursuant to that General Judgment, Columbia County, a political subdivision of the state of Oregon, acquired certain foreclosed real property through deed recorded in the deed records of the Columbia County Clerk as Instrument No. 2007-013480, including a certain parcel of land situated in the City of St. Helens which was formerly owned by Michael R. Hecker; and

WHEREAS, this property is referred to as Tax Map ID No. 4N1W03-BC-00600 and is more particularly described as:

WHEREAS, the property has been assessed at \$500, and is unsuited for construction or placement of a dwelling; and

WHEREAS, pursuant to ORS 275.225, notice of private sale was published in a newspaper of general circulation on July 9, 2008, and more than 15 days has elapsed since publication of said notice; and

WHEREAS, no further offers have been received by the County pursuant to this notice; and

WHEREAS, on June 3, 2008, Lori Dawn Mayo submitted a check to Columbia County in the amount of \$95, the sum of \$50 to purchase this parcel and the sum of \$45.00 to cover recording and handling fees;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

- 1. Pursuant to ORS 275.225, the Board finds this to be a reasonable offer for this property and hereby authorizes the sale of the above-described property to Lori Dawn Mayo for \$50.
- 2. The Board of County Commissioners shall execute the Quitclaim Deed for Tax Map ID No. 4N1W03-BC-00600 to Lori Dawn Mayo, a copy of which is attached hereto as Exhibit 1 and by this reference incorporated herein, for the sum of \$50, receipt of which is hereby acknowledged.
