WHEREAS, on November 3, 2004, *nunc pro tunc* October 29, 2004, the Circuit Court of the State of Oregon for the County of Columbia entered of record the General Judgment in *Columbia County v. Carter, F.F. & Grace L., et al.*, Case No. 04-2352; and

WHEREAS, on November 8, 2006, pursuant to that General Judgment, Columbia County, a political subdivision of the state of Oregon, acquired certain foreclosed real property through deed recorded in the deed records of the Columbia County Clerk as Instrument No. 2006-014613, including this certain parcel of land situated in the City of Vernonia; and

WHEREAS, this property is referred to as Tax Map ID No. 4N4W04-CB-07800 and is more particularly described as:

All that portion of the Northwest quarter of the Southwest quarter of Section 4, Township 4 North, Range 4 West, Willamette Meridian, Columbia County, Oregon lying Easterly of Lot 5, Block 10, town (now city) of Vernonia, and between the Easterly extension of the North and South lines of said Lot 5, and West of tract conveyed to S. A. Miles as described in deed recorded in Columbia County Deed Records Volume N, page 98;

and

WHEREAS, the Board of County Commissioners deemed this property surplus to the County's needs, that the highest and best use would be to an adjoining property owner, and directed that letters be sent to the adjoining property owner(s) advising that the property would be placed for auction; and

WHEREAS, Daryl M. Owen, adjacent property owner, submitted an offer to purchase this parcel to the County; and

WHEREAS, ORS 275.225 permits the County to sell county land by private sale, provided that the property is assessed at less than \$15,000 on the most recent assessment roll prepared for the County, and is unsuited for construction or placement of a dwelling under current zoning ordinances and building codes of the County; and

WHEREAS, the property has been assessed at \$530, and is unsuited for construction or placement of a dwelling; and

WHEREAS, pursuant to ORS 275.225, notice of private sale was published in a newspaper of

general circulation on July 9, 2008, and more than 15 days has elapsed since publication of said notice; and

WHEREAS, no further offers have been received by the County pursuant to this notice; and

WHEREAS, on July 22, 2008, Daryl M. Owen made an offer and submitted a check to Columbia County in the amount of \$255 to purchase this parcel, having previously paid the sum of \$45.00 to cover recording and handling fees;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1. Pursuant to ORS 275.225, the Board considers \$255 to be a reasonable offer for this property and hereby authorizes the sale of the above-described property to Daryl M. Owen for \$255.
2. The Board of County Commissioners shall execute the Quitclaim Deed for Tax Map ID No. 4N4W04-CB-07800 to Daryl M. Owen, a copy of which is attached hereto as Exhibit 1 and by this reference incorporated herein, for the sum of \$255, receipt of which is hereby acknowledged.

QUITCLAIM DEED

The **COUNTY OF COLUMBIA**, a political subdivision of the State of Oregon, hereinafter called Grantor, for the consideration hereinafter stated, does hereby release and quitclaim unto **DARYL M. OWEN**, hereinafter called Grantee, and unto her heirs, successors and assigns, all its right, title and interest in and to the following described parcel of real property situated in the County of Columbia, State of Oregon, described as follows, to wit: **Tax Map ID No. 4N4W04-CB-07800 and Tax Account No. 23084**. The property is more specifically described on the attached Exhibit A.

The true and actual consideration for this conveyance is \$ 255.

BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON TRANSFERRING FEE TITLE SHOULD INQUIRE ABOUT THE PERSON'S RIGHTS, IF ANY, UNDER ORS 195.300, 195.301 AND 195.305 TO 195.336 AND SECTIONS 5 TO 11, CHAPTER 424, OREGON LAWS 2007. THIS INSTRUMENT DOES NOT ALLOW USE OF THE PROPERTY DESCRIBED IN THIS INSTRUMENT IN VIOLATION OF APPLICABLE LAND USE LAWS AND REGULATIONS. BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON ACQUIRING FEE TITLE TO THE PROPERTY SHOULD CHECK WITH THE APPROPRIATE CITY OR COUNTY PLANNING DEPARTMENT TO VERIFY THAT THE UNIT OF LAND BEING TRANSFERRED IS A LAWFULLY ESTABLISHED LOT OR PARCEL, AS DEFINED IN ORS 92.010 OR 215.010, TO VERIFY THE APPROVED USES OF THE LOT OR PARCEL, TO DETERMINE ANY LIMITS ON LAWSUITS AGAINST FARMING OR FOREST PRACTICES, AS DEFINED IN ORS 30.930, AND TO INQUIRE ABOUT THE RIGHTS OF NEIGHBORING PROPERTY OWNERS, IF ANY, UNDER ORS 195.300, 195.301 AND 195.305 TO 195.336 AND SECTIONS 5 TO 11, CHAPTER 424, OREGON LAWS 2007.

This conveyance is subject to the following exceptions, reservations and conditions:

- 1) This property is conveyed AS-IS without covenants or warranties, subject to any municipal liens, easements and encumbrances of record.
- 2) All rights to any County, public, forest or Civilian Conservation Corps roads are hereby reserved for the benefit of Columbia County, Oregon.
- 3) All rights to any minerals, mineral rights, ore, metals, metallic clay, oil, gas or hydrocarbon substances in, on or under said property, if any, including underground storage rights, and also including the use of such water from springs, creeks, lakes or wells to be drilled or dug upon the premises as may be necessary or convenient for such exploration or mining operations, as well as the conducting of operations related to underground storage and production of gaseous substances on the property, are specifically excepted, reserved and retained for the benefit of Columbia County, Oregon, together with the right of ingress and egress thereto for the purpose of exercising the rights hereby excepted, reserved and retained.
