WHEREAS, a majority of the Board of County Commissioners finds that undue harm will result to the following roads, from beginning to end, in the event vehicles in excess of a maximum weight of 10,000 pounds are permitted to travel on the County Roads because of freezing ground (frost heave) and subsequent thawing of the roads:

WHEREAS, the Roadmaster has presented this Application and Order to restrict the use of said roads in accordance with the requirements of the Columbia County Transportation Ordinance.

NOW, THEREFORE, the Board of Commissioners of Columbia County orders as follows:

1. The roads known as Scappoose Dike Road; Honeyman Road; Hankey Road; Pittsburg Road; Canaan Road; Meissner Road; Walker Road, Scappoose; Walker Road, Rainier; Brooks Road; Church Road; Stone Road; Cater Road; Dutch Canyon Road; Callahan Road; Cedar Creek Road; Kingsley Road; Pebble Creek Road; Keasey Road; Fishhawk Road; Tide Creek Road; Nicolai Road;

Fairview Road; Holbrook Road; Beaver Homes Road; Beaver Springs Road; Barker Road; Wonderly Road; Alston Mayger Road; Quincy Mayger Road; Delena Mayger Road; Lost Creek Road; Cedar Grove Road; Swedetown Road; Olson Road; Ilmari Road; Stewart Creek Road; and Rutters Road shall be closed to vehicular traffic with a maximum weight in access of 10,000 pounds.

2. The Roadmaster shall post the roads conspicuously at each end of the section affected by this Order, and shall endorse this Order accordingly.
3. This Order shall be effective upon recording in the Commissioners' Journal, after the fact of posting has been properly endorsed, and shall remain in effect until February 5, 2008, or sooner if, in the Roadmaster's discretion, the weight limits are no longer needed, and the Roadmaster causes the posting to be removed from one or more of the affected roads.
