NOW, THEREFORE, IT IS HEREBY ORDERED:

(1) That the items of County-owned personal property listed in "Exhibit A" are not needed for other public purposes and are therefore declared surplus to the County's needs.

(2) That the Columbia County Finance Director is authorized to offer the items for sale at public auction in accordance with Ordinance No. 88-3, Section 11.E, and and OAR 125-350-020(3) (February, 1985).
