WHEREAS, Ms. White has provided a Certificate Binder for Tenant Users Liability Insurance through TULIP listing Columbia County as an additional insured and indicating that Liquor Liability Coverage has been added to the policy for this event;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

- 1. Ms. White is granted permission to serve alcoholic beverages during her wedding on Saturday, August 22, 2009.
- 2. Alcohol shall be served by an OLCC Service permit holder and Ms. White and/or her designee shall monitor the guests to ensure no excessive alcohol consumption takes place.
