ORDER NO. 82 - 2009

WHEREAS, pursuant to ORS 97.440, the Rainier Cemetery District (hereinafter "the District") brought a proceeding to remove a dedication for cemetery purposes from a portion of Mayger Cemetery located near Rainier, Oregon, before the Board of County Commissioners for Columbia County, Oregon, by filing a *Petition for Removal of Dedication*, a copy of which is attached hereto as Exhibit A and by this reference incorporated herein; and

WHEREAS, Tom Greer, Chair of the Board of Directors of the District represented in the Petition that the portion of the cemetery from which the removal of dedication for cemetery purposes is sought has not previously been used for interment; and

WHEREAS, that portion of Mayger Cemetery from which the District proposed the removal of the dedication is described as Lots 1 - 562, Block 1; Lots 1 - 208, 240-255, 287-302, 334-349, Block 2; Lots 1-16 and 48-53, Block 3; the walkway lying between these three portions; and, that portion of Tract A lying to the East of Block 1 and Lots 1 - 10 and Lots 48 - 53, Block 3, as depicted on the Mayger Cemetery plat recorded in the deed records of the Columbia County Clerk at Book 3, page 49; and

WHEREAS, that portion of Mayger Cemetery from which the dedication is to be removed is depicted on a copy of the Hudson Cemetery Plat which is attached hereto as Exhibit B and by this reference incorporated herein; and

WHEREAS, a public hearing was scheduled for December 1, 2004, at 10:00 a.m. in the Commissioners' Meeting Room, Room 308 of the Columbia County Courthouse, St. Helens, Oregon, as required by ORS 97.440; and

WHEREAS, the Notice of Public Hearing was published once a week for four consecutive weeks in a newspaper of general circulation within Columbia County, and was published twice in a newspaper with statewide circulation; and

WHEREAS, at said hearing John Crawford, Sexton-Manager of the District was present in support of the *Petition for Removal of Dedication* and to testify that no interment of human remains has occurred within that portion of Mayger Cemetery from which the removal of dedication is sought; and

WHEREAS, no further testimony on the Petition was received by the Board; and

WHEREAS, the Board finds that the Petition meets the requirements of ORS 97.440 and that proof satisfactory has been received that the portion of the cemetery for which dedication is sought to

be removed is not being used for interment of human remains.

NOW, THEREFORE, IT IS HEREBY ORDERED AND DECREED that, upon satisfactory payment by the District of the costs of publication of the hearing notice occurred herein, the dedication for cemetery purposes of that portion of Mayer Cemetery designated as Lots 1 - 562, Block 1; Lots 1 - 208, 240-255, 287-302, 334-349, Block 2; Lots 1-16 and 48-53, Block 3; the walkway lying between these three portions; and, that portion of Tract A lying to the East of Block 1 and Lots 1 - 10 and Lots 48 - 53, Block 3, as depicted on Exhibit B, a copy of the Mayer Cemetery plat recorded in the deed records of the Columbia County Clerk at Book 3, page 49, is hereby removed.

**PETITION FOR REMOVAL
OF DEDICATION**

Pursuant to ORS 97.440, the Rainier Cemetery District (hereinafter "the District"), by and through its Board of Directors, hereby petitions the Board of County Commissioners (hereinafter "the Board") for the removal of a portion of the Mayger Cemetery dedicated for cemetery purposes.

1) The District owns the real property on which the Mayger Cemetery, Section 19, Township 8 North, Range 3 West, Willamette Meridian, is located, said property being commonly referred to as Tax Map ID No. 8N3W19-D0-00800, and located on Life Lane & Alston-Mayger-Quincy Rd near Rainier, Oregon. The property is depicted on the map attached hereto as Exhibit A and by this reference incorporated herein.

2) The District is the duly appointed cemetery authority and is entitled to bring this petition under ORS 97.440. A copy of the Certificate of Authority to Operate a Cemetery issued by the Oregon Mortuary & Cemetery Board is attached hereon as Exhibit B and by this reference incorporated herein.

3) The District represents and affirms that the portion of the cemetery from which they seek the removal of the dedication for cemetery purposes has not previously been used for internment.

4) The District desires to remove the dedication for cemetery purposes from a portion of the Mayger Cemetery so that that portion may be sold to the Mayger Downing Church.

5) That portion of the cemetery from which the dedication is sought to be removed is highlighted on the Mayger Cemetery plat, recorded in the deed records of the Columbia County Clerk at, Book 3, page 49, and is more specifically described as, Lots 1 -562, Block 1; Lots 1 - 208, 240-255, 287-302, 334-349, Block 2; Lots 1-16 and 48-53, Block 3; the walkway lying between these three portions; and, that portion of Tract A lying to the East of Block 1 and Lots 1 - 10 and Lots 48 - 53, Block 3, as depicted on the Mayger Cemetery plat, attached hereto as Exhibit C and by this reference incorporated herein.


