**ORDER NO. 9 - 2009**

WHEREAS, pursuant to Ordinance No. 94-9, the Board of County Commissioners may enact rules, regulations and fee schedules for the use of Columbia County forests, parks, beaches, docks and other recreational facilities subject to said ordinance; and

WHEREAS, the Columbia County Board of Commissioners and the Columbia County Forest, Parks and Recreation Advisory Commission have recommended that amendments to the fee schedule be enacted for the use of all Columbia County recreational facilities;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1. The fee schedule for the use of Columbia County forests, parks, beaches, docks and other recreational facilities, attached hereto, labeled Exhibit 1, and incorporated herein by this reference, is hereby adopted, and shall remain in full force and effect until amended or repealed by the Board of County Commissioners.

2. The fee schedule shall become effective and have the force of law when notice thereof is given by posting copies as outlined in paragraph 4 below.

3. All previous fee schedules are repealed and superseded by this Order.

4. The Public Works Director, or his designee, shall give notice of the enactment of this amended fee schedule by posting copies at or by the park host's residence at the parks, if applicable, or on signs placed or erected near the main entrance to any forest, park, beach, dock or other County recreational facilities.

5. The Public Works Director, or his/her designee, shall certify in writing to the Board of County Commissioners the date and method of providing such notice.
