**ORDER NO. 26 - 2010**

WHEREAS, pursuant to Ordinance No. 2003-02, amending Ordinance No. 98-10, effective July 9, 2003, the County has been collecting \$500 deposits to secure construction of access approaches on County and public roads; and

WHEREAS, Ordinance No. 2003-02 required the applicant to complete construction of the access approach within 2 years of permit issuance, or the applicant would forfeit the deposit; and

WHEREAS, those permits listed on the document attached hereto as Exhibit A, incorporated herein by this reference, issued under Ordinance No. 2003-02, have expired and the deposits are subject to forfeiture; and

WHEREAS, notices were mailed to the applicants listed on Exhibit A who had not completed construction within the required 2-year period on March 9, 2009 and March 20, 2010, as reflected on the attached Exhibit A; and

WHEREAS, pursuant to the notice, each applicant was given the right to appeal the forfeiture within 30 days from the notice; and

WHEREAS, the applicants listed in Exhibit A did not appeal the forfeiture within the time given for appeal.

NOW THEREFORE, IT IS HEREBY ORDERED that the deposits listed in Exhibit A are hereby forfeited to the County and that the funds be transferred from the Treasurer's deposit account to the County Road Fund.
