ORDER NO. 38 - 2010

WHEREAS, the Columbia County Forest, Parks and Recreation Rules and Regulations prohibit the use of bows and arrows and other weapons in any County Park, including Camp Wilkerson, without the express permission of the Board of County Commissioners; and

WHEREAS, the Latter Day Saints ("LDS") Girls Camp has applied for a permit to hold its annual camp group meeting for girls twelve to seventeen at Camp Wilkerson, a County park, from 4:00 p.m. on July 12 through 2:00 p.m. on July 17, 2010; and

WHEREAS, LDS has requested permission to conduct archery classes and to use a slip-n-slide during a portion of their reserved-use stay, a copy of said written request being attached hereto as Exhibit A and incorporated herein by this reference; and

WHEREAS, LDS signed a Hold Harmless Agreement indemnifying the County for any injury to person or property arising from its activities during its stay at Camp Wilkerson; and

WHEREAS, LDS has provided a Certificate of Insurance and Additional Insured Endorsement listing Columbia County, its officers, agents and employees, as an additional insured; and

WHEREAS, LDS has given assurances that the use of bows and arrows and the slip-n-slide will be well supervised and done safely, and has further agreed to abide by any conditions placed upon them in connection with these activities;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1. LDS is granted permission to use bows and arrows during scheduled archery classes to be conducted for two-hour periods on Wednesday, July 14, from 1:00 to 3:00 p.m., and Thursday, July 15, 2010, from 2:30 to 4:30 p.m., under experienced, adult supervision consisting of at least one adult for every six youth.
2. The archery classes shall be conducted in the lower meadow, an area of the Park that is segregated by the natural contours of the land from the rest of the Park.
3. The areas where the classes are to be conducted shall be roped off with "caution" or other warning signs and a safety zone or archery backdrop present.
4. All hay bales and/or other items used for the classes shall be removed from the Park prior to or upon departure.


5. LDS is granted permission to use a slip-n-slide for a two-hour period on Friday, July 16, from 2:00 to 4:00 p.m., under adequate adult supervision.

6. The Group shall comply with all park rules and regulations during its use of the park, except as specifically exempted by this Order.


7. The Hold Harmless Agreement signed by a representative of the Latter Day Saints Church is hereby approved.

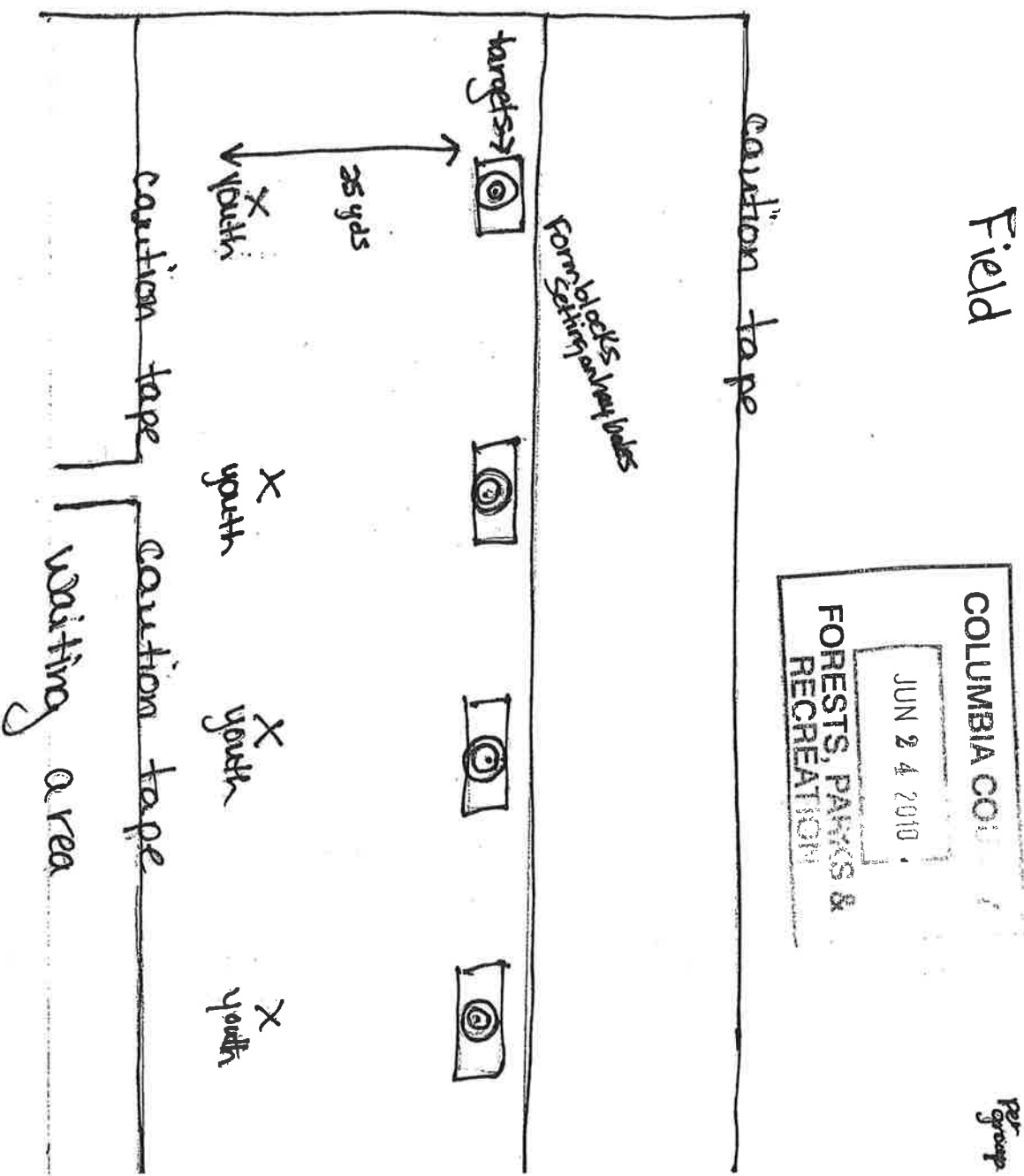
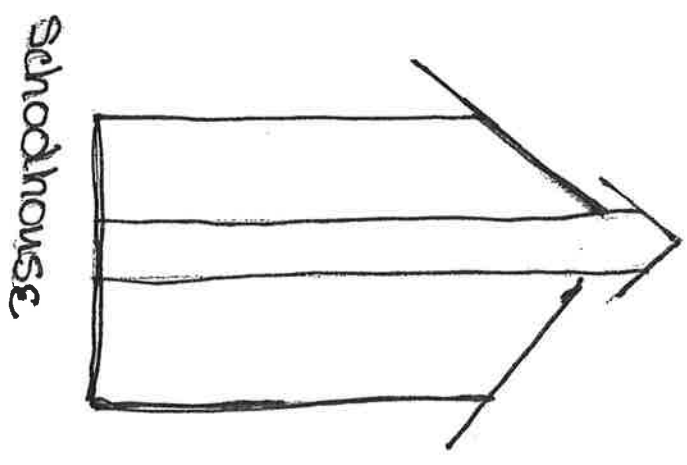
