WHEREAS, on January 28, 2010, Columbia County Animal Control Officer Roger Kadell responded to a call from April Wedgeworth that two dogs had entered her property at 28712 Chapman Road, Scappoose, Oregon, and were attacking and killing her goats; and

WHEREAS, upon arrival at Wes and April Wedgeworth's property, Animal Control Officer Kadell found two goats – a mother goat and her baby goat – both of which had been recently killed; and

WHEREAS, Animal Control Officer Kadell photographed the two dead goats and interviewed Ms. Wedgeworth, who stated that two dogs had entered her property and injured a goat in October 2009, and that the dogs belonged to Dennis Hart; and

WHEREAS, Animal Control Officer Kadell then drove to Mr. Hart's residence at 28611 Melling Drive, Scappoose, where he found a female pitbull dog, "Zoey," and a male pitbull dog, "Gunner," unrestrained and unattended, and he noticed that both dogs had fresh blood on them; and

WHEREAS, Animal Control Officer Kadell transported the dogs back to the Wedgeworth residence where Ms. Wedgeworth positively identified "Zoey" and "Gunner" as the two dogs that had entered her property that day and attacked her goats; and

WHEREAS, having concluded that both dogs attacked and killed livestock, Animal Control Officer Kadell impounded the dogs; and

WHEREAS, Animal Control Officer Kadell photographed the two dogs, both of which had blood on their face and bodies; and

WHEREAS, the feces of the female dog "Zoey" were examined and photographed and contained fur consistent with the dead goats along with bone fragments; and

WHEREAS, on October 27, 2009, Mr. Hart signed a stipulated agreement admitting that "Zoey" had attacked an injured a goat belonging to Wes and April Wedgeworth on October 21, 2009; and

WHEREAS, pursuant to ORS 609.156, Mr. Hart was provided notice of the opportunity to request a hearing in a letter dated February 1, 2010; and

WHEREAS, Mr. Hart did not request a hearing; and

WHEREAS, the Board of County Commissioners considered a summary of the Animal Control Officer's report on this matter, along with the recommendation of the Animal Control Officer; at its staff meeting on March 3, 2010.

NOW, THEREFORE, based on the report of the Animal Control Officer on this matter, attached hereto as "Exhibit A" and incorporated herein by reference, the Board of County Commissioners makes the following findings:

1. Dennis Hart owns the two pitbull dogs, "Zoey" and "Gunner."
2. "Zoey" and "Gunner" entered the property of Wes and April Wedgeworth at 28712 Chapman Road, Scappoose, Oregon, on January 28, 2010, where they attacked and killed two of the Wedgeworth's goats.
3. "Zoey" previously injured livestock belonging to Wes and April Wedgeworth on October 21, 2009.

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1. Based on the livestock attack and kill carried out by Dennis Hart's female dog, "Zoey," on January 28, 2010, a \$1,000.00 penalty is imposed pursuant to ORS 609.162(1)(c).
2. Based on the livestock attack and kill carried out by Dennis Hart's male dog, "Gunner," on January 28, 2010, a \$500.00 penalty is imposed pursuant to ORS 609.162(1)(c).
3. Pursuant to ORS 609.162(1)(c), within 21 days of the mailing of this order, Dennis Hart shall either remove both dogs to a location where, in the opinion of Columbia County, the dogs will not be a threat to livestock, or surrender the dogs to the County for placement in an area where they will not pose a threat to livestock. Otherwise, the dogs shall be deemed surrendered at the end of the 21-day period.
4. Pursuant to ORS 609.155(3)(a), in addition to the \$1,500.00 in civil penalties imposed above, Dennis Hart shall pay all costs and fees arising from the impoundment of the dogs, as described in the Statement attached hereto as "Exhibit B" and incorporated herein by this reference, and all boarding fees at a rate of \$15 per day for each dog, accruing from January 28, 2010, to the date at which Mr. Hart either retrieves the dogs or surrenders them to the County.

5. Any penalties or impoundment and boarding costs and fees imposed by this Order, not paid within twenty-one (21) days of the mailing of this Order, shall be recorded without costs in the County Clerk Lien Record, pursuant to ORS 609.167.

<p>Called County dispatch at around 10:11 hours to report that two dogs owned by Denise Hart were on her property attacking and killing her goats.</p> <p>Ms. Wedgeworth when contacted, stated that she was inside her home when she heard the goats outside in their pen going crazy. She exited her house out the garage side door that leads to the goat area and witnessed two dogs inside her goat fenced areas. The goat fenced area is sub dividing into an inter and outer fenced area. The two dog were inside the second section of fencing where she keeps the mother goat and the baby goat. She could see the mother goat on the ground dead with blood all around her. The two dogs on seeing her crawled back under the fence and ran back towards the back pond area, that leads to the Hart property.</p> <p>Ms. Wedgworth stated that she recognized and could identify the two dogs as the same two dogs that had been to her house back in October 2009 when another goat was kill and a second goat injured. That at that time the dogs belonged to Dennis Hart. She described the dogs as being a Pitt Bull, tan and white and the second, a pitbull mixed with something else, brown and white chest.</p> <p>She stated that at the time she did not want to go into the shed where the baby goat was as she knew she would find it dead. Which was what was found. She then returned to the house and called dispatch to report the attack by the two dogs.</p> <p>While in the house she heard the two remaining goats going crazy again. When she looked out the window she saw both dogs back again trying to get to the fenced area with her remaining two goats. She then called her neighbor Don Bernardi to come over and help.</p> <p>They both then chased the two dogs off. Mr. Bernardi witnessed the dogs and can identify them as being the Hart's dog.</p> <p>Ms. Wedgeworth when we returned around 12:30 with two dogs, clearly identified the two Hart dogs Zoey and Gunner as the dogs that she witnessed attacking and killing her goats.</p> <p>Ms. Wedgeworth listed the value of the goats as being \$200 each . She also requested consideration for damages to her fencing and her husbands lost wages for 1/2 the day as he had to respond home to deal with the deceased goats as she was over whelmed with the situation.</p>

When I arrived, I met with Ms. Sukau and obtained from her the information regarding the events that took place. We then responded to the Hart property located at 28611 Melling Drive, Scappoose Oregon.

As I drove up to the house, I could clearly see the two reported dogs running loose in the larged fenced area next to the house. This fenced area does not full enclose the property but only the front portion of the property. The dog Zoey was one of the two dogs loose in this area in violation of the prior agreement for the return of Zoey signed by Mr. Hart back in October of 2009. In that agreement Zoey was required to be secured in a kennel or on a leash and under direct control of an adult person.

Mr. Hart then came out of the house and I explained to him my reason for being at the house. He at first tried to claim the dogs had only been outside with him all day. I then advised him that I would need to seize the dogs for the livestock attack.

As both dogs came closer, I could clearly see that both dogs had fresh blood on them. My hands became stained with blood from loading the two dogs. I pointed the blood out to Mr. Hart and when I returned to the shelter I took photos of the blood on both dogs.

Mr. Hart was advised that I would contact him later to discuss the options regarding this situation once I had reviewed the case file and todays events and decided what action to take.

I then transported both dogs to the Wedgworth's property, where the victim identified the two dogs as the ones that attacked and killed her goats.

The two dogs were then taken to the Animal Shelter located in Saint Helens and placed in isolation so that a fecal exam of their waste can be conducted.

A review of the history of these dogs showed that on October 21st, both dogs were involved in another livestock incident in which one goat was killed and a second injured. The information at the time lead to Mr. Hart signing to a stipulation of facts that the dog "Zoey" did harm and chase livestock. The evidence against the second dog Gunner was discounted as the goat he was seen dragging was dead the day before and no one had witnessed that attack.

Mr. Hart paid \$395.00 in civil penalties and agreed to restrcitions on the keeping of Zoey. The infomation in this case shows that he was in violation of that agreement at the time of this incident.

My conclusion of this investigation is that both dogs clearly today entered the Wedgeworth's goat pen and attacked and killed two goats on the property. The eye witness account and the blood on both dogs clearly proves the facts in this case.

Based on the information in this case, the livestock attack will be referred to the County Board of Commissioners under ORS 609.155 impounding of dogs for harming livestock. County Counsel will be requested to send a hearings notice to Mr. Hart.

Mr. Hart will also be issued citations for two counts of violations of ORS 609.095 dog as a public nuisance in Justice Court. Resitution will also be requested through Justice Court under ORS 609.140 and 609.990(5).

Placement and disposition of the two dogs will be determined by County Commissioners hearings on the livestock kill. Both dogs have shown to be people and other dog friendly. They however would not be able to be placed in a livestock area. My recommendation would be for the animals to be surrendered to animal control for disposition as they determine best. This would allow for Animal Control to evaluate and look at the options for these two dogs.

### FECAL EXAMINATION/ DOG ZOEY

On 01/29/2010, when I arrived at 8 Am, I checked the kennel belonging to the two dogs owned by the Hart's. The dog Gunner had yet to defecate. The dog Zoey however had defecated.

I then took this fecal waste and examined it for outword signs of the livestock attack. I photo graphed several items noted in the examination. In the examination I noted fur/hair consistent with the victim animals. I also noted blood and bone fragments. The amount of hair/fur in the waste clearly demonstated that the animal had consumed a fur/hair bearing animal. The items from the fecal waste were bagged and stored for additional tested if warranted.
