WHEREAS, on June 2, 2010, pursuant to ORS 198.920, the Scappoose Parks and Recreation District (hereinafter, the "District") adopted Resolution 2010-1, initiating dissolution proceedings for the District, a copy of which is attached hereto as Exhibit A, and is incorporated herein by this reference; and

WHEREAS, on July 7, 2010, Resolution 2010-1 was filed with the County Board of Commissioners; and

WHEREAS, on August 2, 2010, pursuant to ORS 198.925, the District Board adopted Findings of Fact, which are attached hereto as Exhibit B, and are incorporated herein by this reference; and

WHEREAS, the District Attorney submitted the Findings of Fact to the Board of Commissioners and the County Clerk on August 3, 2010; and

WHEREAS, pursuant to ORS 198.930 the District Board has proposed a dissolution plan dated July 20, 2010, a copy of which is attached hereto as Exhibit C, and is incorporated by this reference; and

WHEREAS, pursuant to the District's Plan for Dissolution, the District has no liabilities with the exception of bills for prior District elections from 1984 through 2009, totaling \$23,771.97, and further indicating that the District's only asset is a bank account balance in the amount of \$266.37; and

WHEREAS, according to the District's Plan for Dissolution, the District proposes to convey all District assets to the County, and proposes to have the County waive its right to be reimbursed for the costs of District elections; and

WHEREAS, pursuant to ORS 198.940, the election on dissolution normally required by ORS 198.935 shall be dispensed with and the County Board of Commissioners shall declare the district dissolved and proceed in accordance with ORS 198.945, if the Board finds that dissolution is in the interest of the people of the County, and that the District has failed regularly to elect District Board members in accordance with the Principal Act of the District; and

WHEREAS, the Columbia County Clerk has submitted a letter dated August 31,

2010, establishing that the District has regularly failed to elect District Board members in accordance with the Principal Act of the District; and

WHEREAS, a copy of the Clerk's letter is attached hereto as Exhibit D, and is incorporated herein by this reference; and

WHEREAS, the Board of County Commissioners finds that it is in the best interest of the people of the County to dissolve the District; and

WHEREAS, the Board of County Commissioners finds that the District has failed regularly to elect District Board members in accordance with the Principal Act of the District;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

- 1. The Scappoose Parks and Recreation District is dissolved pursuant to ORS 198.940.
- 2. Pursuant to ORS 198.945, after the affairs of the District have been fully settled all books and records of the District shall be deposited by the board of trustees in the office of the County Clerk. At the same time, the Board of Trustees shall execute under oath, and file with the County Board, a statement that the District has been dissolved and its affairs liquidated. From the date of the statement, the corporate existence of the District is terminated for all purposes.
- 3. The Board of County Commissioners agrees to accept payment in the amount of \$266.37 in full satisfaction of the District's obligation to pay outstanding costs associated with District elections from 1984 to 2009 (\$23,771.97).



The Board of Directors of the Scappoose Parks and Recreation District, having initiated dissolution proceedings, do hereby make the following Findings of Fact as required by ORS 198.925:

- (a) The Board finds that the District has no indebtedness to any bondholder or other similar creditor. The Board acknowledges that it is indebted to Columbia County in the amount of \$23,771.97 for expenses incurred in conducting elections in prior years; and
- (b) The Board finds that the District holds no real property; and
- (c) The Board finds that there are no uncollected taxes or assessments owing to the District from any source; and
- (d) The Board finds that the only personal property held by the District is \$266.37 deposited in account number 346401 with the St. Helens Community Federal Credit Union; and
- (e) The board finds that there should be no costs attributable to dissolution of the District.

These Findings of Fact were duly adopted by the Board at a public meeting held Monday, August 2, 2010, at Scappoose, Oregon. These Findings of Fact are hereby transmitted to the Columbia County Board of Commissioners for further action pursuant to ORS Chapter 198.
