WHEREAS, for surplus property with a current market value of less than \$1,000, the County may offer the items for sale to the public in accordance with Ordinance No. 88-3, Section 11.E and OAR 125-350-015 (February, 1985); and

WHEREAS, the County has entered into a an intergovernmental agreement with the State of Oregon pursuant to ORS 190.110 and ORS 279A.250 to ORS 279A.285 for the sale of certain surplus property, including used Road equipment, in accordance with federal and state laws;

NOW, THEREFORE, IT IS HEREBY ORDERED:


- (1) That the items of County-owned personal property listed above are not needed for other public purposes and are therefore declared surplus to the County's needs; and
- (2) That the disposal, donation or sale of the personal property is clearly in the public interest.
- (3) That the Columbia County Purchasing Coordinator is authorized to dispose of the used Road Equipment, with the exception of Equipment No. 356, by offering the items for sale through the State of Oregon surplus property program.
- (4) That the Purchasing Coordinator shall dispose of Equipment No. 356 in the most efficient and cost-effective method available.
- (5) That the Purchasing Coordinator is authorized to dispose of the computer monitors through the E-Waste Program or any other appropriate, responsible manner.
