WHEREAS, pursuant to ORS 609.167, the Columbia County Board of Commissioners imposed civil penalties in the amount of Two Thousand Dollars (\$2,000.00) and impoundment and boarding fees in the amount of One Thousand Four Hundred Ninety-Five Dollars (\$1495.00) against Edward Ribaya on September 9, 2009, in Order No. 60-2009, a copy of which is attached hereto and incorporated herein by this reference; and

WHEREAS, notice of the determination and imposition of the civil penalties and impoundment and boarding fees was mailed to Edward Ribaya through his attorney, Antonio Porras, on September 16, 2009, by first class mail, return receipt requested pursuant to ORS 609.158; and

WHEREAS, on January 12, 2010, the Columbia County Circuit Court affirmed Order No. 60-2009 on writ of review; and

WHEREAS, Edward Ribaya has not paid the civil penalties and impoundment and boarding fees, filed a request for reexamination, or petitioned for judicial review of the Columbia County Circuit Court's judgment; and

WHEREAS, pursuant to ORS 609.167, the County may record the civil penalties and impoundment and boarding fees imposed under ORS 609.167 in the Columbia County Lien Record if such penalties and fees are not paid within 21 days after mailing of the determination and imposition of the civil penalty and fees.

NOW, THEREFORE, it is hereby ordered as follows:

- 1. The lien shall be against Edward Ribaya.
- 2. The lien shall be in the amount of Three Thousand Four Hundred Ninety-Five Dollars (\$3495.00).

- 4. County Counsel's office is authorized to enforce the lien pursuant to ORS 205.125 and ORS 205.126.
