WHEREAS, on July 23, 2008, the Board of County Commissioners adopted Ordinance No. 2008 - 2, establishing the Homeland Security Emergency Management Commission (the "HSEMC"); and

WHEREAS, Ordinance No. 2008 - 2 calls for the Board to appoint members to the HSEMC; and

WHEREAS, Steve Butsko, appointed to the HSEMC as the Primary to the Mid-County Cities position, has left the state and can no longer serve on behalf of the Mid-County Cities; and

WHEREAS, Frank Grace, appointed to the HSEMC as the Alternate to the Mid-County Cities position, has left the City of Vernonia and can no longer serve on behalf of the Mid-County Cities; and

WHEREAS, Gerry Meyers, appointed to the HSEMC as the Primary to the Port of St. Helens position, has left the Port of St. Helens and can no longer serve on its behalf; and

WHEREAS, the position of the alternate to the Industry position has never been filled; and

WHEREAS, the Board desires these positions of the HSEMC to be filled; and
