ORDER NO. 77 - 2010

WHEREAS, following the flood event of 2007, numerous items of personal property were donated to Columbia County for use by the Unmet Needs Committee (UNC) to assist in flood recovery efforts; and

WHEREAS, the UNC has determined that several of the donated items are no longer needed for flood recovery efforts, or are in such disrepair as to be unusable; and

WHEREAS, a list of those items is attached hereto as Exhibit A and by this reference incorporated herein; and

WHEREAS, the UNC has determined that those items of personal property which are of no value and are not needed for use by Columbia County should be disposed of in a responsible manner, including recycling; and

WHEREAS, the UNC has determined that several items of personal property with minimum value can be used by other non-profit agencies, and should be donated; and

WHEREAS, the remaining items were deemed by the UNC to have a current market value per item of less than \$1,000, and, pursuant to Ordinance No. 88-3, Section 11.E, and OAR 125-350-015(2), the County may establish a selling price, schedule and advertise a sale date.

NOW, THEREFORE, IT IS HEREBY ORDERED:

- (1) That the items of personal property listed on the attached Exhibit A are not needed for public purposes and are therefore declared surplus to the County's needs.
- (2) That the disposal of the personal property is clearly in the public interest.
- (3) That the UNC is authorized to dispose of the Items of no value in the most efficient and cost-effective method available.
- (4) That the UNC is authorized to donate items to other non-profit agencies as shown in Exhibit A.

(5) That the UNC is authorized to establish a selling price, schedule and advertise a sale date for the remaining items of personal property, the proceeds of which shall go to the UNC.
