WHEREAS, Ms. Austin has signed a Hold Harmless Agreement indemnifying the County for any injury to person or property arising from his activities during their stay at Camp Wilkerson; and			
WHEREAS, Ms. Austin has provided a Certificate Binder for Tenant Users Liability Insurance through TULIP listing Columbia County as an additional insured;			
NOW, THEREFORE, IT IS HEREBY ORDERED that Sarah Anne Austin is granted permission to serve alcoholic beverages during her wedding from 2:00 p.m. on September 11, 2011, to 11:59 p.m. on September 11, 2011. Alcohol shall only be served by an OLCC Service permit holder and Ms. Austin and/or her designee shall monitor the guests to ensure no excessive alcohol consumption takes place.
