WHEREAS, at the July 12, 2011, meeting, the Committee approved a recommendation to the Board of Commissioners that a Zone-Based Fare System be established and an increase in fares be approved; and

WHEREAS, a map of said Zone-Based Fare System is attached hereto as Exhibit 1 and by this reference incorporated herein; and

WHEREAS, a spreadsheet showing said Fare Increases is attached hereto as Exhibit 2 and by this reference incorporated herein; and

WHEREAS, on August 10, 2011, the Board of County Commissioner's held a public hearing to consider the proposed Zone-Based Fare System and fare increases for the Columbia County Rider Transportation System, and continued the hearing to August 24, 2011, for deliberations and to allow for greater public input to be obtained; and

WHEREAS, on August 24, 2011, the Board continued deliberations to September 7, 2011, to consider additional information submitted and on September 7, 2011, continued the deliberations to September 14, 2011;

NOW, THEREFORE, IT IS HEREBY ORDERED that a Zone-Based Fare System for Columbia County Rider be established and that the proposed fare increases as listed on the Proposed Fare Change attached hereto as Exhibit 1 be and the same hereby are adopted effective October 1, 2011.


