ORDER NO. 8 - 2012

WHEREAS, on December 28, 2011, the Board of County Commissioners adopted Ordinance No. 2011 - 4 which amended the Columbia County Enforcement Ordinance, Ordinance No. 92 - 15, to make general housekeeping amendments and to incorporate position and personnel changes; and

WHEREAS, subsequent to the adoption of Ordinance No. 2011 - 4, two additional Fair Board members have been appointed, Amanda McFeron and Jilian Olson, who should be given authority under the Columbia County Enforcement Ordinance to enforce certain statutes, rules, ordinances, orders and resolutions, and provisions thereof, covered by the Enforcement Ordinance; and

WHEREAS, the Columbia County Sheriff has requested that two additional deputies, Deputy Bill Goodwin and Civil Deputy Alan Haebe, be given authority under the Columbia County Enforcement Ordinance, Ordinance No. 92-15, as amended, to enforce certain statutes, rules, ordinances, orders and resolutions, and provisions thereof, covered by the Enforcement Ordinance; and

WHEREAS, the Columbia County Sheriff has indicated that the Letters of Authority previously issued to Reserve Deputies James Carnahan and Scott Williams, who have left the Sheriff's Office, should be revoked and their names stricken from Exhibit B to Ordinance No. 2011 - 4; and

WHEREAS, the Columbia County Sheriff has further indicated that Deputy Scotty King, listed in Exhibit B to Ordinance No. 2011 - 4 is in reality Deputy Dustin King, and Exhibit B should be changed to reflect that correction and a new Letter of Authority issued to Deputy Dustin King, and that there is no Reserve Deputy Ryan Pews and this name should be stricken from Exhibit B;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

- 1) Letters of Authority issued to Deputies James Carnahan and Scott Williams are hereby revoked.
- 2) Fair Board members Amanda McFeron and Jilian Olson, Deputy Bill Goodwin and Civil Deputy Alan Haebe are granted authority and jurisdiction over, and may enforce, those statutes, administrative rules, ordinances, orders and resolutions, and provisions as referenced, upon issuance of a Letter of Authority by the Board of County Commissioners.
- 3) Exhibit B attached to Ordinance No. 2011 - 4 shall be amended as shown on Attachment 1, attached hereto and incorporated herein by reference.

4) All other provisions of Ordinance No. 2011 - 4 remain unchanged and in full force and effect.

5) Letters of Authority shall issue to Amanda McFeron, Jillian Olson, Deputy Bill Goodwin and Civil Deputy Alan Haebe.

6) A Letter of Authority shall be issued to Deputy Dustin King, and the Letter of Authority erroneously issued to Scotty King shall be revoked.
