

1. Tommy Carr, who resides at 60749 Flack Road, Oregon, is the owner of Saber, a black and white Husky.
2. On July 18, 2012, Saber harmed and chased chickens on Penny Costley's property at 1282 Louisiana Avenue, Vernonia, Oregon. During the attack, Saber killed seven chickens and injured one. Saber, therefore chased and harmed livestock in violation of ORS 609.155.
3. According to Columbia County Animal Control, Saber has no prior record of killing, wounding, injuring or chasing livestock.

NOW, THEREFORE, IT IS HEREBY ORDERED that Columbia County Animal Control shall release Saber to Tommy Carr, subject to the following conditions:

1. Tommy Carr shall take measures to prevent recurrence, including compliance with the conditions set forth in the Settlement Agreement, attached hereto as Exhibit "B."
2. Pursuant to ORS 609.162(1)(b), a civil penalty of \$500.00 is imposed on Tommy Carr for the livestock attack carried out by his dog Saber. Mr. Carr shall pay \$50.00; the remaining \$450.00 of the civil penalty shall be suspended provided Mr. Carr continues to comply with the Settlement Agreement.
3. Pursuant to ORS 609.155(3)(a), in addition to the civil penalty imposed, above, Tommy Carr shall pay all costs and fees arising from the impoundment of the dog, as described in the Statement of Costs, attached hereto as Exhibit "C" and incorporated herein by this reference, and all boarding fees at a rate of \$15 per day for Saber, accruing from July 18, 2012, to the date at which Mr. Carr retrieves Saber from Animal Control.
4. Any penalties or impoundment and boarding costs and fees imposed by this Order shall be paid prior to the release of Saber, unless otherwise agreed to in writing by the County.

NARRATIVE SUMMARY: On 07/18/2012 around 12 noon, a male Husky dog was apprehended in the act of killing seven chickens at the address of 1282 Louisiana Ave in Vernonia. The dog is currently impounded at the animal shelter for harming and chasing livestock per ORS 609.155.								
NARRATIVE: On 07/18/2012, I responded to the address of 1282 Louisiana Ave in Vernonia Oregon on a report that a dog was inside the callers chicken coop killing her chickens. When I arrived, I found a black and white

Husky dog sitting inside the fenced chicken area surrounded by deceased chickens. I noted that the dog had feathers in his mouth and around his head area, as well as imbedded in his paws. The dog appeared to be happy and proud of his accomplishments.

I spoke with the chicken owner, Penny Costley. She advised that she did not notice the dog when she came home. That she went into her home and had stepped out onto her upper deck area. That she looked down into the fenced coop area and saw the Husky dog inside surrounded by dead chickens. She then ran out to the chicken coop area and found the dog inside with a dead chicken in his mouth. The dog remained in the chicken coop mauling on the dead chickens while she counted and found that 7 chickens were dead. She then took photos of the dog in case he escaped and ran away.

I then removed the dog from the chicken coop area and took photos of the seven dead chickens. I found one chicken that had been injured and was still alive hiding inside the wood portion of the chicken coop. The Husky dog was checked for tags and/or micro chip and none were found. Ms. Costley advised that she had not seen the dog before.

I spoke with Ms. Costley about her chickens. She told me that they were 1 1/2 years old and prime laying hens. That some of the ones at the home were four H project chickens of her daughters. That she was lucky in that the rest of her four H chickens went to the fair this morning. I advised her to consider the cost of damages and to let me know what the replacement cost of the animal was.

The Husky dog was then taken back to the Animal Shelter in Saint Helens where he was impounded for harming and chasing livestock. A supervisor hold was placed on the dog. Ownership of the dog was unknown at the time of this report.

FOLLOW UP:

On 07/20/2012, I spoke with Indigo rescue in Vernonia Oregon. They advised me that one of their volunteers Linda had been out looking for a Husky dog in Vernonia on the 19th. Indigo was able to provide me the name Tommy and the phone number of 503-724-0104 for the dog owner.

I called the number and spoke with Tommy Carr. He described his missing dog as a black and white husky with blue eyes wearing a black collar with little bones on it and that the dog was missing from the Texas Ave area of Vernonia. This matched in description and area for the dog.

I then informed him of the issues with the dog having killed seven chickens and the process that would be needed for the return of the dog. We discussed and I advised that I would send him by e-mail a stipulated agreement for him to review. I then prepared the attached agreement and sent it to him via e-mail. I included the notice of impound and a copy of a photo of the dog Saber.

A complaint has been filed indicating that a dog owned by you has been involved in the harming or chasing of livestock in violation of ORS 609.155. **ORS 609.155 provides that upon complaint of evidence of a dog harming or chasing livestock that the dog "shall be impounded" pending the a determination by the county if the dog harmed, or chase livestock.**

You will receive notice of an opportunity to request a hearing under ORS 609.156 and information on the hearing process from the County Attorney. Pending the outcome of the hearing the dog at issue will remain in the custody and care of the Columbia County Animal Control.

The penalty and fees for actions of a dogs found to having harmed and chased livestock can be considerable. Serious consideration regarding the hearing process should be considered. Failure to request a hearing within the notification process will result in the finding that the owner is conclusively presumed to have admitted the matter alleged and the county may take action under ORS 609.162 and 609.163.

In this case you may have also been issued a citation for violation of ORS 609.095 dog as a public nuisance, ORS 609.100 unlicensed dog, and /or ORS 609.060 dog running at large. These violation will be separate issue directed to the Justice Court and independent of the harming or chasing livestock issues before the County Board of Commissioner.

SETTLEMENT AGREEMENT

This Settlement Agreement ("Agreement") is entered into by and between Columbia County, a political subdivision of the State of Oregon, and Tommy Carr.

RECITALS

WHEREAS, Tommy Carr is the owner of the dog "Saber," described as a black and white Husky; and

WHEREAS, evidence shows that on July 18th, 2012, Saber chased, attacked, and killed seven chickens, belonging to Penny Costley, within a fenced enclosure on Penny Costley's property; and

WHEREAS, Saber was impounded at the Columbia County Animal Shelter pursuant to ORS 609.155 for harming and killing livestock; and

WHEREAS, Columbia County Animal Control initiated a proceeding before the Columbia County Board of Commissioners to determine whether Saber's actions constitute a violation of ORS 609.155 and to determine costs and fees; and

WHEREAS, Mr. Carr has elected to waive his right to a hearing on the violation and enter into this Settlement Agreement with Columbia County for the release of Saber and disposition of the violation; and

WHEREAS, Mr. Carr has advised Columbia County Animal Control that he and Saber will be relocating to a residence within the city of Hillsboro.

AGREEMENT

In consideration of the mutual promises set forth below, the parties hereby agree as follows:

Tommy Carr hereby admits that his dog, Saber, chased and killed livestock, and agrees to the following:

1. Saber will be secured within the home or a fenced yard when not under the observation and control of a adult person.
2. Saber will be micro chipped by Columbia County Animal Control and will be registered with the Department of Agriculture as required under ORS 609.168.
3. In the event Saber escapes, the Animal Control agency with jurisdiction will be immediately notified and advised of Saber's history of killing chickens.
4. Columbia County Animal Control will be immediately notified if Saber is sold, transferred or re-homed.
5. Any acts of aggression by Saber towards any person or livestock animal will be reported to Animal Control within 24 hours at 503-397-3935.

6. ORS 609.162(c) requires a minimum civil penalty of \$500.00. Mr. Carr shall pay \$50.00. The remaining \$450 shall be suspended provided Mr. Carr continues to comply with this agreement.
7. Mr. Carr shall pay all impound, boarding, micro chip, civil penalties prior to the release of Saber.
8. Mr. Carr will pay restitution for the livestock killed in the amount of \$280 under ORS 609.140 and 609.190. Mr. Carr shall submit such restitution to Columbia County.
9. Failure to comply with any of the above terms will constitute a violation of ORS 609.095 (maintaining a dog as a public nuisance). Saber will also be subject to impoundment, and suspended penalties may be sought.

Tommy Carr further agrees to release and hold harmless Columbia County, its officers, agents and employees for any and all claims, suits or actions of any nature, including claims of injury to any person or persons or of damage to property arising out of the County's impoundment of the dog Saber and enforcement of ORS 609.155.

Columbia County hereby agrees to release Saber upon payment of all penalties, fees and costs. The County further agrees to make payment for damages to the Costleys in the amount of \$280.00 under ORS 609.170.
