WHEREAS, Section 5.01(A) of the Columbia County Solid Waste Management Ordinance ("SWMO") authorizes the Board of County Commissioners, upon its own recommendation or the recommendation of the Solid Waste Advisory Committee (SWAC), to approve and establish rate adjustments; and

WHEREAS, Section 5.01(A)(4) of the SWMO authorizes the Board to increase or decrease rates based on the cost of doing business; and

WHEREAS, Section 5.01(B)(6) of the SWMO provides that in determining rates, the Board shall give due consideration to, among other things, a reasonable rate of return to the franchisee based upon a percentage of gross receipts under the franchise; and

WHEREAS, in May 2014, the SWAC At-Large Members and County Staff reviewed proposed rate adjustments for curbside collections services by Waste Management, for its rural Scappoose and Vernonia franchise service areas, and Waste Connections (dba Hudson Garbage Service) for its rural St. Helens, Clatskanie, and Rainier franchise service areas; and

WHEREAS, the proposed rate adjustments were supported by Detail Cost Reports (DCRs) submitted by Waste Management and Waste Connections/Hudson. The 2013 DCRs that Waste Management submitted showed operating margins within 8-14% for the rural Scappoose and Vernonia areas. The 2013 DCRs that Waste Connections/Hudson submitted showed an operating margin of 7.5% for the rural St. Helens, 5.8% for rural Clatskanie, and 0.1% for rural Rainier; and

WHEREAS, the SWAC policy is to recommend a hauler-requested rate adjustment to the Board when the operating margin for the franchise area falls below 8%; and

WHEREAS, following review of the DCRs, the SWAC voted unanimously to recommend rate adjustments for curbside collection services for the rural St. Helens, Clatskanie and Rainier franchise areas, served by Waste Connections/Hudson, to the Board of County Commissioners. The rate adjustment would allow for an 11% operating margin for those three franchise areas. For Rainier specifically, SWAC recommended that the 11% target be achieved through a \$2.50 monthly charge to residential customers for recycling services plus a 6.5% increase for all customers; and

WHEREAS, the SWAC also recommended a disposal pass-through rate increase of \$0.24 for all franchise areas, in accordance with Section 5.01(A)(4), to incorporate the annual Consumer Price Index (CPI) adjusted rates for disposal at the transfer station; and

WHEREAS, following published notice, the Board held a hearing on July 2, 2014 on the proposed rate adjustments for curbside collection services by franchised haulers for residents and businesses in rural Columbia County; and

WHEREAS, after deliberating on the proposed rate adjustments, the Board determined that an increase of \$.0.24 for all franchise areas is necessary as a pass-through to cover the transfer station's annual CPI-adjusted disposal rate; and

WHEREAS, the Board also determined that the SWAC recommended rate increase for the rural St. Helens, Clatskanie and Rainier franchise areas, which provide for an 11% operating margin, are necessary to cover the costs of the waste-disposal program without reducing services to the public; and

WHEREAS, the Board found that the operating margin for the rural Scappoose and Vernonia franchise areas did not justify a rate adjustment at this time, other than to accommodate the CPI-adjusted, pass-through rate for disposal.

NOW, THEREFORE, IT IS HEREBY ORDERED, as follows:

1. In addition to the findings in the staff's Board communication dated June 25, 2014, attached hereto as Exhibit A and incorporated herein by this reference, the Board adopts the following supplemental findings:
  - A. That based on the cost of doing business, an increase in curbside collection rates for the rural St. Helens, Clatskanie and Rainier franchise areas is justified; and
  - B. That the proposed increase in curbside collection rates for the rural St. Helens, Clatskanie and Rainier franchise areas are just, fair, reasonable, and sufficient to provide proper service to the public; and
  - C. That the proposed increase in curbside collection rates to pass through the CPI-adjusted disposal rate increase is justified for all franchise areas and is just, fair, reasonable and sufficient to provide proper service to the public.
2. The Board adopts rate increases in curbside collection services proposed in Exhibit A, including Option B for Rainier, which establishes a \$2.50 increase for residential customers for recycling services plus a 6.5% increase for all Rainier customers.



3. The rate increases shall be effective August 1, 2014.

2014 Collection Rate Adjustments**

## **SUMMARY:**

Each year, the County reviews solid waste collection rates using a uniform Detailed Cost Report(DCR) rate review procedure established in 2011 which is designed to provide the information necessary for the County to make rate setting decisions pursuant to Section 5.01 of the Solid Waste Management Ordinance(**Attachment 1**). Under the DCR procedure, an operating ratio for each collection service area is determined using detailed cost data presented by each collection franchisee in a standard format prescribed by the County. The operating ratio is a measure, expressed as a percentage, of what proportion of a collection franchisee's revenue is left over, before taxes, after paying for the variable costs of providing the service. The Solid Waste Advisory Committee has established a policy that an acceptable operating ratio will be in the range of 8-14% with a target operating ratio of 11%. If the DCR for the previous year indicates an operating ratio which is less than 8%, a rate adjustment to the target 11% would be made. If the operating ratio falls within the 8-14% acceptable range, no rate adjustment would be allowed. In response to Board questions. Staff has prepared a memo addressing the the background and rationale for the current SWAC operating margin policy used in formulating the Staff/SWAC recommendation (**Attachment 2**).

In April 2014, Waste Management and Waste Connections, the two solid waste collection franchisees serving rural Columbia County, submitted Detailed Cost Reports (DCRs) to the Columbia County Solid Waste Advisory Committee (SWAC) At- Large members and Staff. A map of the franchise collection service areas served by our collection franchisees is contained in **Attachment 3**. The DCRs were reviewed by SWAC at public meetings on May 1, May 15 and May, 22, 2014. Staff provided the DCRs to Board, reviewed the rate requests and outlined the recommendations of Staff and SWAC at a Staff meeting on June 11, 2014. The Board referred the rate requests to a public hearing on July 2, 2014. Required public notice for the rate hearing was provided per the Solid Waste Management Ordinance.

## **TRANSFER STATION DISPOSAL FEE PASS-THRU ADJUSTMENTS**

Transfer Station disposal rates are adjusted each year based on the prior year CPI. The CPI for 2013 was 2.8%. The CPI increase for disposal will be passed through to the collection franchisee customer and included with the change in the collection service rate. The CPI disposal rate increase is 2.8%, increasing the commercial tonnage rate from \$82.75 to \$85.07 per ton and increasing the the curbside collection rate for once a week residential service by \$.24 per month.

## **PROPOSED RATE ADJUSTMENTS:**

Detailed Cost Reports and related rate adjustment proposals for Columbia County's two franchised solid waste collection haulers are described below.



### **Waste Management(Rural Vernonia and Rural Scappoose Service Areas)**

The detailed cost report(DCR) data for the Waste Management franchise area(Vernonia and Scappoose unincorporated areas) indicated that operating margins were within the established range of 8-14%. Therefore, no rate adjustment for these rural collection franchise service areas are justified in 2014. Rates for rural Vernonia and rural Scappoose service areas will be subject only to the Transfer Station 2.8% CPI pass-thru monthly rate increase of \$.24 for once a week residential service (**Attachment 4**). Currently, all Scappoose and Vernonia rural residential customers receive every-other-week (EOW) curbside recycling services in conjunction with solid waste collection, the cost of which is built into the collection rate. Waste Management has not proposed any changes to its services to their rural Scappoose and Vernonia customers in 2014.

The 2014 change in rates for every week residential collection service is summarized as follows:

### **Waste Connections(Rural St. Helens, Rural Clatskanie and Rural Rainier Service Areas)**

Proposed rate adjustments and supporting confidential detailed cost report(DCR) data for the Waste Connections franchise areas(Clatskanie, St. Helens and Rainier unincorporated areas) are contained in **Attachment 5**. Currently, all St Helens, Clatskanie, and Rainier rural residential customers receive every-other-week (EOW) curbside recycling services in conjunction with solid waste collection, the cost of which is built into the collection rate No new services are proposed for the unincorporated Clatskanie, St. Helens or Rainier service areas in 2014. Waste Connections notes changes in revenue and expenses that require the rate increase include a decline in projected commodity sales revenue (-22%), increases in wage costs(+2.5%) and medical benefit costs(+6.2%). A Transfer Station 2.8% CPI pass-thru monthly disposal rate increase of \$.24 for once a week residential service will apply to each of Waste Connection's rural collection service areas.

**Rural St. Helens Service Area:** The DCR indicates a projected operating margin of 7.5%. This is below the acceptable range of 8-14%. The DCR supports a rate increase of 4.62% to achieve the target operating ratio of 11%.

**Rural Clatskanie Service Area:** The DCR indicates a projected operating margin of 5.8%. This is below the acceptable range of 8-14%.. The DCR supports a rate increase of 6.6% to achieve the target operating ratio of 11%.

**Rural Rainier Service Area:** The DCR indicates a projected operating ratio of 0.1%.This is well below the acceptable range of 8-14%.. The DCR supports a rate increase of 14.1% for all classes of customers(Option A) **OR** a \$2.50 monthly charge to residential customers plus a 6.5% increase for all customers(Option B) to achieve the target operating ratio of 11%. Waste Connections added every-other-week (EOW) curbside recycling services to rural Rainier area customers in 2012 and added \$3.80 per month to the residential customer rate, but notes that it significantly under projected expenses and over projected revenues for this added service contributing to the drop in operating margin for this franchise area for 2013.

The Solid Waste Advisory Committee is recommending Option B, adding the \$2.50 to residential



customers receiving curbside recycling services and a 6.5% increase for all customers. SWAC felt that the added cost of service attributable to curbside recycling should be born directly by the curbside recycling customer and not borne by non-residential customers. Option B would cost the residential customer \$.84/mo more than Option A.

Typical residential collection service rates for Waste Connection's service areas would be adjusted as follows:

#### RECOMMENDATION:

The Solid Waste Advisory Committee, public members, Mike Sheehan, Sally Marson and myself meet heard presentation by Waste Connections and Waste Management regarding their respective collection service detailed cost reports and related rate requests on 5/1/14. SWAC met again with Waste Connections on 5/15/14 to further review the DCRs and to review additional information requested. On 5/22/14, SWAC deliberated concerning Waste Connection's rate request.

Based on a review of detailed cost reporting information submitted in support of the franchise hauler requests, SWAC and Staff recommend approval of the above described collection franchisee rate adjustments, selecting Option B for the rural Rainier service area.

# ATTACHMENT 1

## CHAPTER V RATES FOR COLLECTION AND DISPOSAL SERVICE

### Section 5.01 Determination Of Rates

(A) Upon recommendation by the Committee or upon its own recommendation, the Board may by ordinance, order, or resolution and after public hearing:

(1) Approve and establish rates filed by applicants for franchises if it finds that such rates are not demonstratively unreasonable and are not substantially higher than those charged generally in the county under similar service requirements and for the same or similar quality of service or it may establish a different rate schedule.

(2) Establish uniform rates throughout the county or establish rates that are uniform within zones based upon the length of haul to disposal sites, concentration of customers, and other factors which may, in the opinion of the Board, justify establishment of rate differentials.

(3) Establish rates for disposal sites that are uniform throughout the county or different rates for each site or class of sites.

(4) Increase or decrease rates based on the cost of doing business.

(5) Establish an interim rate until the Board makes a final determination of the rate for that type of service.

(B) In determining rates, the Board shall make a finding that the rates will be just, fair, reasonable, and sufficient to provide proper service to the public. The Board may consider rates charged by other persons performing the same or similar service in the same or other areas. The Board shall give due consideration to:

(1) The investment in facilities and equipment.

(2) The services of management.

(3) Local wage scales.

(4) The concentration of customers in the area served.

(5) Methods of storage, collection, transportation and disposal, salvage, recycling, or reuse.

- (6) A reasonable return to the franchisee, based upon a percentage of gross receipts under the franchise.
- (7) The length of haul to disposal facilities.
- (8) The cost of disposal.
- (9) The use of transfer stations or transfer systems and the added costs.
- (10) The cost of alternate methods of disposal.
- (11) The future service demands of the service area or disposal site which must be anticipated in equipment, facilities, personnel or land.
- (12) Extra charges for special pickups or pickups on days where service is not normally provided on collection route.
- (13) Extra charges where the type of character of waste or solid waste, including but not limited to, wastes with peculiarly offensive odors, requires special handling or service.
- (14) Extra charges for providing janitorial services on the premises where service is provided.
- (15) In addition, with respect to disposal sites, the type of site, whether the site is open to the public and houses, type of wastes disposed of and method of disposal.
- (16) Cost of compliance with laws, ordinances or regulations and rules of public agencies or bodies having jurisdiction.
- (17) Other factors which may, in the opinion of the Committee and the Board, necessarily affect the rates to be charged.
- (C) The Board may require an investigation by the Committee of any proposed rates. For the purpose of making this investigation, the Administrator shall assist the Committee and the Committee is authorized to hold public hearings and to take and receive testimony. Upon completion of such an investigation the Committee shall report the results of any public hearing, its finding and its recommendations to the Board.
- (D) Applications for rate adjustments shall be made on the form provided by the Solid Waste Administrator and must provide all information required by the Administrator.

#### Section 5.02 Rate Preferences Prohibited



(A) No franchisee subject to rate regulation by this ordinance shall give any rate preference to any person, locality or type of solid waste stored, collected, transported or disposed.

(B) Nothing in this section is intended to prevent:

(1) The reasonable establishment of uniform classes of rates based upon length of haul, type of solid wastes stored, collected, transported or disposed of or the number, type and location of customers served or upon other factors as long as such rates are reasonably based upon costs of the particular service and are approved by the Board in the same manner as other rates.

(2) Any person from volunteering service at reduced cost for a charitable, community, civic or benevolent purpose.

#### Section 5.03 Responsibility For Payment For Charges For Service

Any person who received service shall be responsible for payment for such service. After notice, in writing and mailed to the landlord of any premises, the landlord shall be responsible for payment for service provided to those premises if the tenant does not pay for the service.

#### Section 5.04 Passing Through Of Certain Rate Changes

(A) Notwithstanding the provisions of Sections 5.01 and 5.02, upon recommendation by the Administrator or upon its own recommendation, the Board may, by order or resolution, approve the passing through to customers on a proportional basis any changes in disposal site and transfer station rates that are authorized by governmental bodies.

(B) In allocating the fee changes in fees and costs to the classes of customers, the Board shall use the following formula:

(1) Residential Customers: An increase or decrease of two and one quarter cents (\$.0225) per can for each \$1.00 per ton change in fee.

(2) Container (Drop Box) Customers: An increase or decrease of fifteen cents (\$.15) per loose yard for each \$1.00 per ton change in fee.

(3) Transfer Station Customers: An increase or decrease of \$1.00 per ton (\$.0005 per pound) for each \$1.00 per ton change in fee.

(C) The date that the increased or decreased disposal fees and/or costs are imposed on the franchise holder shall be the same effective date that such fees and/or

costs are imposed on the customers and rates may be adjusted retroactively to accomplish this goal.

**RE: Columbia County Solid Waste Advisory Committee Rate Setting Policy: Operating Margin Range and Targets**

**DATE:** June 19, 2014

At the Board's staff meeting on June 11, 2014, the Board asked staff to provide more information concerning the annual solid waste collection rate review process used by staff and the Solid Waste Advisory Committee as a basis to determine if rate adjustments are justified and to recommend to the Board the amount of such adjustments. In particular, the Board wanted to know more about the acceptable operating margin policy which is used to determine the collection franchisee's revenue requirement and related rate adjustment, if any. This information is provided in the form of the answers to several questions presented below.

## **Why did SWAC adopt a rate setting policy and procedure?**

Prior to 2010, there was no standardized reporting format nor process for reviewing annual rate requests from solid waste collection companies. Land Development Services used a CPA, Chris Bell, to review franchisee requests and report findings to the staff and the SWAC. SWAC applied the general rate setting policy in Section 5.01 of the Solid Waste Ordinance (SWO). But the SWO simply set a policy of approving and establishing rates if the County found them "not demonstrably unreasonable" and to "increase or decrease rates based on the cost of doing business". The SWO listed allowable and unallowable expenses but did not prescribe how these costs were to be reported, for what period they were to cover and what an acceptable franchisee rate of return or operating margin should be so that the revenue requirement and the rates necessary to raise it could be set. The SWO simply required that applications for rate adjustments be made on forms provided the Solid Waste Administrator and contain all information required by the Solid Waste Administrator.

## **When was the current SWAC rate setting policy and procedure adopted? On what was it based?**

In July, 2010, SWAC reviewed rate setting policies, procedures and reporting forms from several surrounding counties including Clackamas, Washington and Yamhill. SWAC adopted detailed cost reporting forms(DCRs) used by Clackamas County modified to reflect unique characteristics of Columbia County and decided to draft and adopt a new written policy and



procedure for rate setting for use beginning in 2011. SWAC wanted a written policy on an acceptable operating margin included in this document (see July 13, 2010 minutes attached).

In September 2010, Staff presented information on the operating margin policies of surrounding counties. The information indicated that an operating margin of between 8-12% with target operating margins within the range was typical of most jurisdictions. Franchisees argued that rural areas required a larger return on investment than denser urban areas with the same operating margins. After much discussion, a compromise was reached between industry and public SWAC members for an operating margin range of between 8-14% with a target operating margin of 11%. It was agreed that staff would develop an Annual Rate Review Policy and Procedure Manual based on previously approved reporting forms and operation margin guidelines (see September 2, 2010 minutes attached).

SWAC reviewed various drafts of the Annual Rate Review Policy and Procedures Manual in its October 2010 and January 2011 meetings. SWAC adopted the manual at their meeting on April 26, 2011(see manual attached) and first implemented the new manual policies and procedures for the 2011 annual rate setting process at their meetings on May 13, 2011 and May 18, 2011.

**What is operating margin? Why is a defined operating margin policy needed for rate setting? What is the basis for setting an operating margin range and target?**

Operating margin is defined in the County's Annual Rate Review Manual as a measurement of what proportion of a company's revenue is left over, before taxes, after paying for variable costs of production as wages, raw materials etc. Expressed as a formula it is:

$$OM = ((\text{Gross Revenue} - \text{Allowable Expenses}) / \text{Gross Revenue}) * 100$$

Why is a target operating margin policy needed? First, a target operating margin is needed to establish a reasonable return to franchisees which then can be used to determine the rates necessary to raise the required revenue. Second, it can provide an ongoing incentive to control costs. If franchisee costs increase during the rate year-for example, due to a rise in fuel costs or reduction in recycling revenue-franchisees will not achieve the target operating margin set in the prior rate process. However, if franchisees are able to contain or reduce costs, they will earn an operating margin higher than the target operating margin. Those costs will then be the basis for the next year's rate review.

Why establish a range of acceptable operating margins? A policy which sets an acceptable range of operating margins such as that adopted by SWAC of 8-14% serves at least two purposes. First, the range limits the frequency of rate adjustments from year to year. If a franchisee's operating margin falls in the range in the year prior to the rate setting year, they are not eligible for a rate increase. In the case of the County's policy, a franchisee would have to achieve an operating margin either under 8% or over 14% to justify a rate adjustment either upward or downward respectively. Secondly, as mentioned above, by giving the franchisee an opportunity to make an operating margin of between 11 and 14% without having to adjust the rate downward, the County is providing an incentive to the franchisee to contain costs.



In establishing the County's target operating margin and operating margin range, SWAC looked at policies of surrounding communities. It was noted that acceptable operating margins were set higher in rural areas than in urban areas due to factors such as the density of customers. In a June 2012 audit of customer rates in the City of Portland, it was noted that a survey of Metro jurisdictions indicated that most jurisdictions set rates based on a range of 8-12% and a target of 10%. The report found that the City of Portland's target of 9.5% was in line with other urban area rate setting policy. Therefore, Columbia County's policy in our rural area is 8-14% with a target of 11% which is reasonable considering customer density, distances to the Transfer Station etc. in our area.

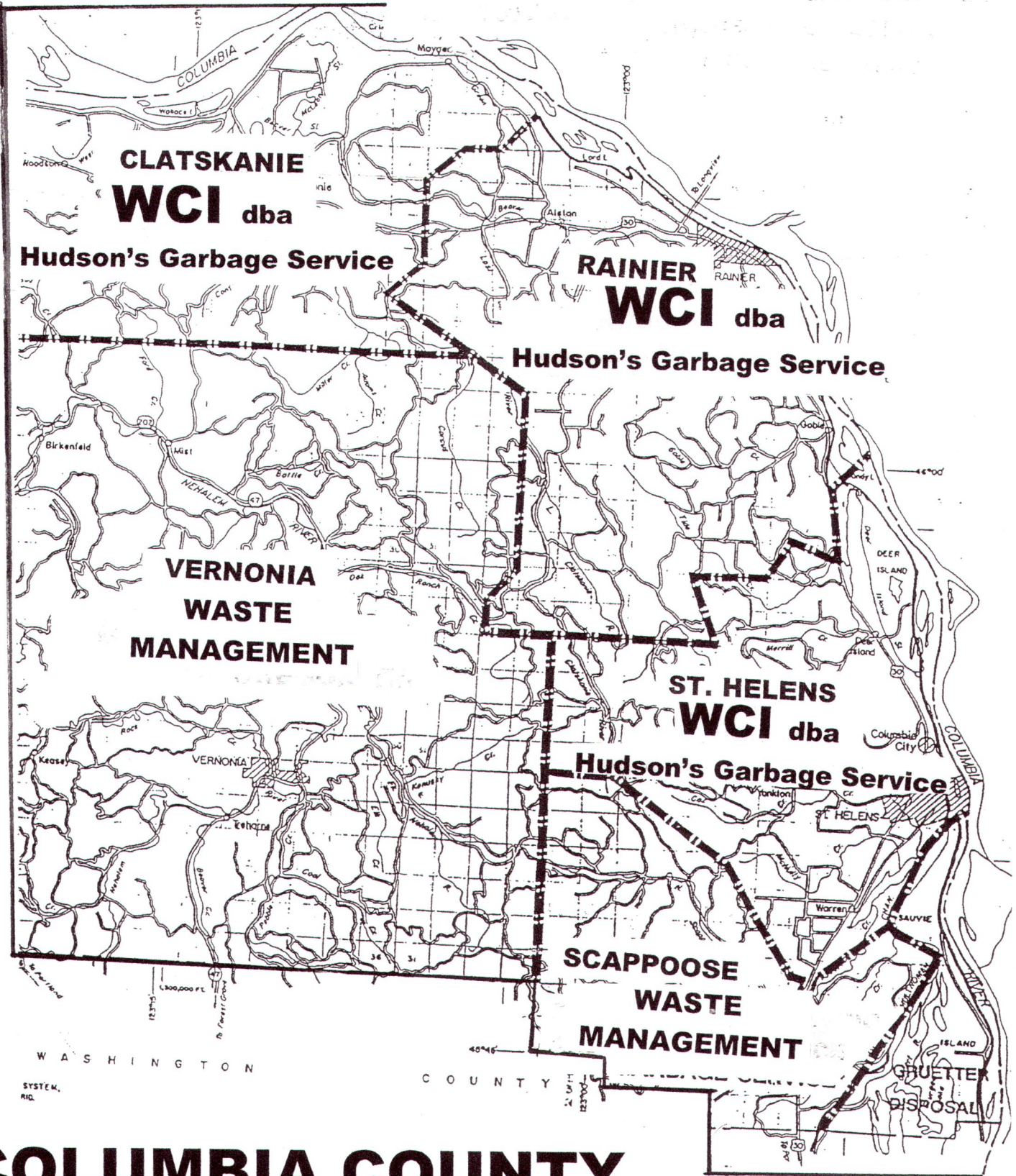
### **Some Final Observations**

In looking at our current Annual Rate Setting Policy and Procedure, I would like to offer several observations:

1. Our current policy has provided a means to easily see, analyze and compare collection system costs and revenues from year to year. It provides staff and SWAC with the tools they need to formulate a sound rate recommendation to the Board.
2. Since the Annual Rate Setting Manual has been adopted by SWAC and not be the Board nor included in the Solid Waste Ordinance or franchise agreements, the Board is not bound by these policies. The Board may approve, modify or deny rate adjustments based on its own findings consistent with the Solid Waste Ordinance whether or not consistent with the Annual Rate Setting Manual.
3. Our operating margin policies are in line with other rural service areas.
4. To be effective our policy must be based on the accuracy of reported costs and revenues. Currently, reported costs are complete and are in a commonly accepted financial accounting format. However, in part as a cost cutting measure, we have recently not been using a CPA or other qualified financial analyst to assist staff and SWAC review the DCRs as a basis for recommendations on rates to the Board. We have been fortunate that our public SWAC members have financial acumen. Next year we should obtain consultant services to analyze the DCRs and present that analysis to staff and SWAC **or** we should require that the DCRs submitted by franchisees be certified by an independent CPA.
5. We should consider changes to our rate setting policies to provide additional incentives to franchisees to increase our reduction, recycling and reuse rates in the County.
