WHEREAS, the new private road serves three properties known as Tax Map ID Numbers 4119-021-00300, 4119-021-00200, and 4119-021-00301, and all three property owners have signed the petition in support of naming the private road; and
WHEREAS, the Director of Land Development Services has reviewed the petition and determined that naming the private road would serve the interest of the public and be beneficial to the County; and
WHEREAS, in accordance with the criteria set forth in Section 7.04 of the Columbia County Rural Addressing Ordinance No. 2015-1, the Director recommends the private road be named "Leader Lane." The Director's reasoning is set forth in the Board Communication, attached hereto as Exhibit A and incorporated herein by this reference.

### **SUMMARY:**

Penny Leader has applied for a new Private Road that is located off Evergreen Lane in Warren a as shown on the attached maps. Presently there are 3 property owners who will be able utilize this new private road; all have signed the attached application and stated they do not have issues with the applicant's first name choice of "Leader Lane." All agencies who were notified have no issues with this new private road name.

After the Board's approval of the applicant's proposal, Land Development Services will provide 3 new addresses off Leader Lane for all three affected property owners and will notify all affected agencies of these new addresses.

## FINDING:





## New Private Road off Evergreen Lane






# Zoning Map Private Road off Evergreen Lane
