### **SUMMARY:**

Quentin and Amy Frugia have applied for a new Private Road that is located off Columbia River Highway in Warren a as shown on the attached maps. Presently there are 3 property owners who will be able utilize this new private road; all have signed the attached application and stated they support the applicant's first name choice of "Century Drive." All agencies who were notified have no issues with this new private road name.

After the Board's approval of the applicant's proposal, Land Development Services will provide 3 new addresses off Century Drive for all affected property owners and will notify the affected agencies of these new addresses.

### FINDING:

The submitted application for the naming of "Century Drive" meets criteria set forth in Section VII, Road Names, of Ordinance 81-6 as amended; specifically Subsection 7.04 regarding the naming of private roads.


