Freitag is to dedicate as additional right-of-way to the public for road and utility purposes forever their property along Robinette Road, St. Helens, Oregon, such additional right-of-way being required for replacing the existing Robinette Road Culvert to correct a fish passage barrier on Dart Creek that will allow increased access to rearing habitat for salmonids and spawning habitat for adult Coho and Steelhead. 
