#### BEFORE THE BOARD OF COUNTY COMMISSIONERS

### FOR COLUMBIA COUNTY, OREGON

In the Matter of Amending the Columbia County ) ORDER NO. 92-2019 Building Code )

WHEREAS, Columbia County administers the State Building and Specialty Codes and additional regulations under the Columbia County Building Code; and

WHEREAS, pursuant to Section 3B of the Columbia County Building Code Ordinance, the Board may, by order or resolution, adopt subsequent editions of the State Building Code and additional related codes as necessary to stay current with state statutes and administrative rules or as otherwise may be in the best interests of the citizenry of Columbia County, Oregon; and

WHEREAS, State Building and Specialty Codes apply statewide and are no longer required to be adopted by municipalities, as defined in ORS 455.010(5) to include counties; and

WHEREAS, ORS 455.020(4) provides that the State Building and Specialty Codes do not limit the authority of municipalities to enact regulations providing for local administration of the State Building Code; and

WHEREAS, Columbia County administers the State Building and Specialty Codes as authorized by ORS Sections 455.153, 445.185, 447.020(2), 455.020(2), 455.525, 455.570, 455.610 to 455.635, 456.915 to 456.950, 460.085, 460.360, 479.730(1) and 480; and

WHEREAS, State Building and Specialty Codes allow municipalities with delegated Building Inspection Programs to adopt related local regulations that are more restrictive than the current state codes; and

WHEREAS, the 2019 Oregon Structural Specialty Code ("OSSC") Chapter 1, Scope and Administration, provides a narrower scope of authority for administering the State Building Code than the 2014 OSSC, Chapter 1, Scope and Administration. The 2019 OSSC identifies twenty-six (26) types of buildings and structures that will not be regulated by the code, which were regulated under the 2014 OSSC. The State Building Code Division made this change based on a finding that it only has authority to regulate buildings and structures used for human occupancy pursuant to ORS 455.020; and

WHEREAS, Columbia County Building Official recommends that the Columbia County Board of County Commissioners adopt the 2014 OSSC Chapter 1 into the County Building Code to allow the County to maintain its current scope of authority under 2014 OSSC. The Building Official also recommends other amendments to the County Building Code to reflect that the State Building Code and Specialty Codes are automatically adopted pursuant to statute; and

WHEREAS, the Board has determined it is in the best interests of the citizenry of Columbia County to adopt Chapter 1 of the 2014 OSSC and amend the Columbia County Building Code;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

ORDER NO. 92-2019

- 1. The Columbia County Building Code is hereby amended as shown in Exhibit A, attached hereto and incorporated herein by this reference.
- 2. This order shall be effective on January 1, 2020.
