WHEREAS, the new private road serves four properties known as Tax Map ID Numbers 7223-BO-00800, 7223-BO-00801, 7223-BO-00802 and 7223-BO-00803; and

WHEREAS, the petitioner's 1st choice road name, Edgewater Drive, for the new private road does not conflict with any other road names in the County; and

WHEREAS, the Director of Land Development Services has determined that the petition meets the criteria set forth in Ordinance No. 81-6 (Rural Addressing Ordinance), Sections 7.04 and 7.05, as amended, regarding the naming of private roads; and

WHEREAS, the Director of Land Development Services has determined that under the circumstances, naming the private road would serve the interest of the public and be beneficial to the County, and recommends petitioner's 1st choice, "Edgewater Drive". The Director's recommendation is attached hereto as Exhibit A and is incorporated herein by this reference;

DATE: February 18, 2020

SUMMARY:

Michael Melchiori submitted an application to name a new Private Road as required by Sections 7.04 and 7.05 2 of the Columbia County Rural Addressing System Ordinance, which allows citizens to petition the Board to name a private road that serve three or more residences.

There are currently two other established homes on the properties served by the existing driveway that needs to be named in accordance with the provisions in the Columbia County Rural Addressing System Ordinance. The affected properties currently served by the proposed private road are in the ownership of Harvey Bilton, Pamela Harrison and the applicant and are associated with current Tax Map Identification Numbers 7223-B0-800/801, 7223-B0-00802, and 7223-B0-00803. All affected property owners have signed the submitted Private Road Naming Application.

Should the Board of Commissioners approve the applicant's request, Land Development Services will officially re-address and notify all affected properties and agencies of this decision. All future development served by this new private road will also be addressed by Land Development Services at time of building permit issuance. All necessary improvements to this new private road and related signage shall be approved by the Columbia River Fire & Rescue (CRF&R); documentation of these improvements shall be submitted to Land Development Services.

Notification of the proposed road renaming was sent to Columbia 911, the County Public Works Department, the County Cartographer, Columbia River Fire & Rescue, the Rainier Post Office, and the County Cartographer.

FINDINGS:

The submitted application for the naming of "Edgewater Drive" meets criteria set forth in Section VII, Road Names, of Ordinance 81-6 as amended; specifically 7.04 3 Naming of Private Roads

and 7.05 Citizen Request for Road Names.

Land Development Services Staff, Columbia 911, the Rainier Post Office, and the Columbia River Fire & Rescue support the 1st choice of "Edgewater Drive" and find no conflicting road names with the applicant's choice.

RECOMMENDATION:

Staff recommends approval of the applicant's 1st choice for the private road to be named "Edgewater Drive."





RR-5 Zoning Map- Road 24




