WHEREAS, this supplemental budget #14 is for General Fund-Non Departmental and increases the fund's budget by more than 10%; and

WHEREAS, ORS 274.473 requires a public hearing if the amended estimated expenditure in the fund differs by more than 10% from the expenditures in the fund's budget: and

WHEREAS, the County published notice of a hearing on the supplemental budget on June 17, 2020; at least 5 days before the hearing; and

WHEREAS, a public hearing was held on the supplemental budget for the above fund on June 24, 2020;

NOW, THEREFORE, IT IS HEREBY RESOLVED that the 2019-2020 fiscal year budget for Columbia County be modified as detailed in *Exhibit A* for the specific purpose of providing appropriations to cover expenditures through June 30, 2020.
