### BEFORE THE BOARD OF COUNTY COMMISSIONERS

### FOR COLUMBIA COUNTY, OREGON

In the Matter of a Livestock Attack by Dogs Owned by Donald Denham

ORDER NO. 11-2021

WHEREAS, Columbia County Animal Control Deputy Roger Kadell's investigation report, attached hereto as Exhibit "A" and incorporated herein by this reference, provides relevant facts in this matter; and

WHEREAS, on March 4, 2021, Deputy Kadell received a call from Cheryl Knight, who reported that three husky dogs owned by her neighbor, Donald Denham, were attacking another neighbor's livestock and she fired a shot to scare the dogs away from her property; and

WHEREAS, on March 4, 2021, Deputy Kadell received a call from Shannon Garcia, who reported that her daughter, Alayna Cary, chased the three dogs away from her property, located at 16130 River Front Rd, Clatskanie, OR 97016, and two of her pigs were injured by the dogs; and

WHEREAS, on March 4, 2021, Shannon Garcia sent Deputy Kadell photographs of the pigs' injuries and stated she was concerned for the safety of her livestock because the dogs were loose on Donald Denham's pasture and appeared to be watching her property. Copies of these photographs are included in Deputy Kadell's investigation report on this matter, attached hereto as Exhibit "A"; and

WHEREAS, on March 5, 2021, Deputy Kadell interviewed Shannon Garcia, Alayna Cary, Cheryl Knight and Donald Denham separately; and

WHEREAS, during the interview with Shannon Garcia, Deputy Kadell observed that two of Shannon Garcia's pigs were injured; one of the pigs had several bite marks down its back, a large chuck of flesh removed, missing a tail and several bite marks near the tail area; and

WHEREAS, Alayna Cary provided Deputy Kadell a diagram and a written statement about the incident, which stated that she watched the dogs run from her mother's property to Donald Denham's property as he yelled out for the dogs to come home and as the dogs ran home they would stopped and look back at her mother's property; and

WHEREAS; Deputy Kadell found that all three of the dogs attacked the pigs; and

WHEREAS, Cheryl Knight reported to Deputy Kadell that she observed three or four dogs going towards Shannon Garcia's property; she then began hearing geese making a warning noise and pigs squealing; and heard Alayna Cary yelling at the dogs to leave; and

WHEREAS; Donald Denham reported to Deputy Kadell that when the incident occurred he was inside of his house and noticed on his property camera that something was happening with his dogs in the field; he called out for the dogs, and he then went into the field to retrieve the dogs; and

WHEREAS; Donald Denham informed Deputy Kadell that three of his dogs, named Brownie, Mocha and Cookie, husky mixed breed, were involved in the incident; and

WHEREAS; Deputy Kadell found that all three dogs attacked and injured the pigs; and

WHEREAS, based on the information obtained during Deputy Kadell's investigation, he impounded the dogs under ORS 609.155 for chasing and harming livestock; and

WHEREAS, on March 16, 2021, pursuant to ORS 609. 156, the County mailed Donald Denham notice of an opportunity to request a hearing on this matter; and

WHEREAS, on March 22, 2021, Donald Denham provided the County with a written request for a hearing on this matter; and

WHEREAS, on March 23, 2021, the County mailed Donald Denham notice that a hearing was scheduled on this matter; and

WHEREAS, on March 31, 2021, the Board of County Commissioners held a hearing and considered the testimony and evidence presented; and

WHEREAS, Deputy Kadell recommended that the Board of County Commissioners impose a civil penalty under ORS 609.162(1)(b) in the amount of \$500.00 per dog and payment of impoundment and boarding fees; and

WHEREAS, the Board of County Commissioners considered Deputy Kadell's investigation report on this matter, along with his recommendation;

NOW, THEREFORE, based on the evidence presented, including Deputy Kadell's investigation report on this matter, attached hereto as Exhibit "A", and the above recitals, the Board of County Commissioners makes the following findings and conclusions:

- 1. Donald Denham is the owner of dogs named Brownie, Cookie, and Mocha, husky mixed breed.
- 2. On March 4, 2021, Brownie, Cookie, and Mocha chased and injured two pigs, belonging to Shannon Garcia, at 16130 River Front Rd, Clatskanie, OR 97016.
- 3. According to Deputy Kadell, Brownie, Cookie, and Mocha have no prior record of killing, wounding, injuring or chasing livestock under ORS 609.162(2). There is no evidence in the record for this matter to find that Brownie, Cookie, and Mocha previously killed, wounded, injured or chased livestock. Therefore, the Board of

County Commissioners finds that Brownie, Cookie, and Mocha have not previously killed, wounded, injured or chased livestock.

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS HEREBY ORDERS: that Columbia County Animal Control shall release Brownie, Cookie and Mocha to Donald Denham, subject to the following conditions:

- 1. Within 30 days of the date of this Order, Donald Denham shall relocate Brownie, Cookie and Mocha to a location where, in the Columbia County Animal Control Deputy's sole opinion, the dogs will not present a threat to livestock.
- 2. Brownie, Cookie and Mocha shall not be located anywhere in Columbia County where the dogs may present a threat to livestock.
- 3. Brownie, Cookie and Mocha shall not return to the property located at 78429 Point Adams Rd, Clatskanie, OR 97016.
- 4. Pursuant to ORS 609.162(1)(b), a civil penalty of \$500.00 per dog is imposed on Donald Denham for the livestock attack carried out by Brownie, Cookie and Mocha.
- 5. Pursuant to ORS 609.155(3)(a), in addition to the civil penalty imposed above, Donald Denham shall pay \$1,125.00 in fees arising from the impoundment of Brownie, Cookie and Mocha, as described in the Fee Due Notice, attached hereto as Exhibit "B" and incorporated herein by this reference, and all boarding fees at a daily rate of \$15.00 per dog for the period of March 19, 2021 through March 31, 2021. Boarding fees will continue to incur until the dogs are released in accordance with this Order.
- 6. Donald Denham shall pay all penalties, impoundment, boarding fees imposed by this Order, prior to the release of the dogs, unless otherwise agreed to in writing by the County.
- 7. Brownie, Cookie and Mocha shall be deemed surrendered to the County if Donald Denham does not retrieve the dogs within 30 days of the date of this Order. In the event that any of the dogs are surrendered to the County, the County may rehome or euthanize the surrendered dog and Donald Denham shall pay a relinquishment fee of \$65.00 per dog and euthanasia fee, if applicable, of \$85.00 per dog.

8. Donald Denham shall make a payment of at least 25 % of the total civil penalties, impoundment and boarding fees imposed by this Order prior to the release of Brownie, Cookie and Mocha, unless otherwise agreed to in writing by the County. Donald Denham shall pay the remaining balance in equal payments within six months of retrieving the dogs.

	Ms. Cary statement showed that two of the dogs had attacked the more seriously injured pig and had the pig down in the ditch. The third was up by the barn area attempting to get into the goat and chicken area. All three dogs were considered involved in this attack. Ms Cary said she watched the dogs run back home as the owner was out yelling for them. She said that the however would stop and look back at her and the pigs.									
	I then drove to the reporting witness Cheryl Knight home at 78473 Point Adams road. She is the neighbor to the dog owner Don Denham and has had livestock attack issues with the same group of dogs in 2019. Ms. Knight told me that she had just arrived home when she saw a third pig in her back pasture area. That the pig had walked over near the fence line with the neighbors dogs. She said that the dogs were all getting worked up and repeatedly hit the fence line. This third pig had been owner by a person down the River front Road area and had escaped. The owner had been unable to load the pig to return it home.
