ORDER NO. 65-2021

[Public Works Department Equipment &
Vehicles]

WHEREAS, the Columbia County Public Works Department has determined that the items of County-owned property listed in Exhibit A, attached hereto and incorporated herein by this reference, are no longer needed for use by Columbia County and should be declared surplus and disposed of in accordance with the Columbia County Public Contracting Rules (Ordinance No. 2015-2, as amended); and

WHEREAS, the items listed in Exhibit A have a current market value ranging between \$2,000 and \$20,000; and

WHEREAS, under the Columbia County Public Contracting Rules (Ordinance No. 2015-2, as amended), items that the County no longer needs may be declared surplus and disposed of by certain approved methods; and

WHEREAS, the Public Works Department proposes to dispose of the surplus property by first offering the items to other public entities and then by public auction to the highest bidder, both of which are approved methods under the County's Public Contracting Rules;

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS HEREBY ORDERS:

1. The property identified in Exhibit A is declared surplus to the County's needs.
2. The property identified in Exhibit A shall be offered to other public entities and/or sold at public auction.
3. The Finance Director is authorized to sign titles transferring the ownership of the vehicles.
