In the Matter of Repealing a Temporary Policy)
Limiting Unmasked Access to County Facilities In)
Response to COVID-19) Order No. 10-2022

WHEREAS, on March 13, 2020, the Board of County Commissioners adopted Resolution No. 25-2020, declaring an emergency for Columbia County to address the spread of COVID-19 and authorizing the Board to take actions and issue orders necessary to protect the public and minimize or mitigate the effect of the emergency; and

WHEREAS, on March 18, 2020, the Board of County Commissioners adopted Order No. 27-2020 "In the Matter of Adopting a Temporary policy to Limit Access to County Facilities in Response to COVID-19"; and

WHEREAS, COVID-19 is a highly contagious and novel Coronavirus, for which there is no vaccine, and the public, including Columbia County employees, are at risk for contracting the disease; and

WHEREAS, on March 23, 2020, the Office of the Governor issued Executive Order No. 20-12, "Stay Home, Save Lives" which implemented workspace restrictions for State Government buildings, among other requirements applicable to all persons in the State of Oregon; and

WHEREAS, in conformance with Executive Order No. 20-12, on March 25, 2020, the Board of County Commissioners adopted Order No. 31-2020, In the Matter of Adopting a Temporary Policy to Close County Facilities to the Public in Response to COVID-19; and

WHEREAS, on May 14, 2020, the Office of the Governor issued Executive Order 20-25, "A Safe And Strong Oregon: Maintaining Essential Health Directives In Response To Covid-19, And Implementing A Phased Approach For Reopening Oregon's Economy", authorizing Columbia County businesses and residents to enter into Phase 1 re-opening consistent with the regulations set forth in the Executive Order; and

WHEREAS, Consistent with the need to re-open services on June 1, 2020, the Board of County Commissioners adopted Order No 42-2020 In the Matter of Adopting Temporaray Policy Limiting Access to County Buildings, which included closure of the Old Courthouse to the Public; and

WHEREAS, the Board of County Commissioners subsequently adopted Order No. 84-2020 to provide greater public access to the Courthouse Annex during tax and election seasons; and

WHEREAS, on June 25, 2021, the Office of the Governor issued Executive Order No. 21-15 repealing Executive Order No. 20-66, the successor to the original Executive Orders, "Stay Home, Save Lives and "Safe and Strong Oregon", effective June 30, 2021; and

WHEREAS, Executive Order No. 21-15 repealed health and safety restrictions such as mask and face shield requirements, capacity restrictions and physical distancing requirements for the County; and

WHEREAS, in response to Executive Order No. 21-15, the Board of County Commissioners adopted Order No. 34-2021, repealing the mask mandate in County operated facilities; and

WHEREAS, effective August 13, 2021, the Office of the Governor again ordered that masks were required for all indoor spaces; and

WHEREAS, in response the Governor's order, the County adopted Order No. 43-2021, limiting unmasked access to County facilities in response to COVID-19; and

WHEREAS, the Office of the Governor has announced that the indoor mask mandate will expire effective March 12, 2021;

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS HEREBY ORDERS, as follows:

1. Effective March 12, 2022, Order No. 43-2021, "In the Matter of Adopting a Policy Limiting Unmasked Access to County Facilities in Response to COVID-19" is hereby repealed.
2. All County departments with public-facing functions shall continue to implement procedures for setting and managing service by phone, on-line, or by appointment, when necessary.


3. CC Rider and the Columbia County Jail shall continue to comply with all Federal and State guidance related to public transportation and congregate care facilities.
