WHEREAS, the Oregon Parks and Recreation Department is accepting applications for the Local Government Grant Program; and

WHEREAS, the General Services Department desires to participate in this grant program to the greatest extent possible as a means of providing needed park and recreation acquisitions, improvements and enhancements; and

WHEREAS, the Board of Commissioners have identified the renovation of the playground at Hudson-Parcher Park as a high priority need in Columbia County; and

WHEREAS, this renovation would include the replacement of the existing play structures and making the playground ADA accessible; and

WHEREAS, the General Services Department has sufficient funds in its budget to meet the local matching funds requirement of this grant should the grant funds be awarded; and

WHEREAS, the General Services Department has adequate funding for on-going operations and maintenance of this park and recreation facility should the grant funds be awarded; and

NOW, THEREFORE, IT IS HEREBY RESOLVED:

1. The Board of Commissioners for Columbia County supports and authorizes the submittal of an application to the Oregon Park and Recreation Department for a Local Government Grant for the renovation of the Hudson-Parcher Park playground; and
2. The Director of the Columbia County General Services Department is hereby authorized to sign on behalf of the County all documents necessary to make application for the Local Government Grant.

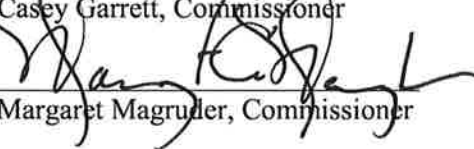
